INTRODUCTION TO ALL THE ISSUES

This paper presents calculations of various economic indicators for the Russian Federation in *July 2020* to *December 2020*¹, which were performed using time series models developed as a result of research conducted by the Gaidar Institute over the past few years.² A method of forecasting falls within the group of *formal* or *statistical* methods. In other words, the calculated values neither express the *opinion* nor *expert evaluation* of the researcher, rather they are calculations of future values for a specific economic indicator, which were performed using formal ARIMA-models (p, d, q) given a prevailing trend and its, in some cases, significant changes. The presented forecasts are of inertial nature, because respective models rely upon the dynamics of the data registered prior to the moment of forecasting and depend too heavily on the trends, which are typical of the time series in the period immediately preceding the time horizon to be forecast. The foregoing calculations of future values of economic indicators for the Russian Federation can be used in making decisions on economic policy, provided that the general trends, which were seen prior to forecasting for each specific indicator, remain the same, i.e. prevailing long-term trends will see no serious shocks or changes in the future.

Despite that there is a great deal of data available on the period preceding the crisis of 1998, models of forecasting were analyzed and constructed using only the time horizon which followed August 1998. This can be explained by the findings of previous studies³, which concluded, among other key inferences, that the quality of forecasts was deteriorated in most of the cases when the data on the pre-crisis period was used. Additionally, it currently seems incorrect to use even shorter series (following the crisis of 2008), because statistical characteristics of models based on such a short time horizon are very poor.

Models for the economic indicators in question were evaluated using standard methods of time series analysis. Initially, the correlograms of the studied series and their first differences were analyzed in order to determine the maximum number of delayed values to be included into the specifications of a model. Then, the results of analyzed correlograms served as the basis for testing all the series for weak stationarity (or stationarity around the trend) using the Dickey–Fuller test. In some cases, the series were tested for stationarity around the segmented trend using Perron and Zivot–Andrews tests for endogenous structural changes.⁴

The series were broken down into weak stationary, stationary near the trend, stationary near the trend with structural change or difference stationary, and then models, which corresponded to each type (regarding the levels and including, if necessary, the trend or segmented trend or differences), were evaluated. The Akaike and Schwartz information criteria, the properties of models' residuals (lack of autocorrelation, homoscedasticity and normality) and the quality of the in-sample-forecasts based on these models were used to choose the best model. Forecast values were calculated for the best of the models constructed for each economic indicator.

Additionally, the Bulletin presents future monthly values of the CPI, which were calculated using models developed at the Gaidar Institute, and volumes of imports/exports from/to all countries, which were calculated using structural models (SM). The forecast values based on the structural models may, in some cases, produce better results than ARIMA-models do, because structural models are constructed by adding information of the dynamics of exogenous variables. Besides, the use of structural forecasts in making

aggregated forecasts (i.e. forecasts obtained as average value from several models) may help make forecast values more accurate.

The dynamics of the Consumer Price Index was modeled using theoretical assumptions arising from the monetary theory. The following was used as explanatory variables: money supply, output volume, the dynamics of the ruble-dollar exchange rate, which reflects the dynamics of alternative cost of money-keeping. The model for the Consumer Price Index also included the price index in the electric power industry, because the dynamics of manufacturers' costs relies heavily on this indicator.

The baseline indicator to be noted is the real exchange rate, which can influence the value of exports and imports, and its fluctuations can result in changes to the relative value of domestically-produced and imported goods, though the influence of this indicator turns out to be insignificant in econometric models. Global prices of exported resources, particularly crude oil prices, are most significant factors, which determine the dynamics of exports: a higher price leads to greater exports of goods. The level of personal income in the economy (labor costs) was used to describe the relative competitive power of Russian goods. Fictitious variables D12 and D01 – equal to one in December and January and zero in other periods – were added so that seasonal fluctuations were factored in. The dynamics of imports is effected by personal and corporate incomes whose increase triggers higher demand for all goods including imported ones. The real disposable cash income reflects the personal income; the Industrial Production Index reflects the corporate income.

The forecast values of foreign exchange rates were also calculated using structural models of their dependence on global crude oil prices.

The forecast values of explanatory variables, which are required for forecasting on the basis of structural models, were calculated using ARIMA-models (p, d, q).

The paper also presents calculations of the values of the Industrial Production Index, the Producer Price Index and the Total Unemployment Index, which were calculated using the results of business surveys conducted by the Gaidar Institute. Empirical studies show¹ that the use of series of business surveys as explanatory variables² in forecasting models can make forecasting more accurate on the average. Future values of these indicators were calculated using ADL-models (seasonal autoregressive delays were added).

The Consumer Price Index and the Producer Price Index are also forecast using large datasets (factor models – FM). The construction of factor models relies basically on the evaluation of the principal components of a large dataset of socio-economic indicators (112 indicators in this case). The lags of these principal components and the lags of the explanatory variable are used as explanatory variables in these models. A quality analysis of the forecasts obtained for different configurations of the factor models was used to choose a model for the CPI, which included 9th, 12th and 13th lags of the four principal components, as well as 1st and 12th lags of the variable itself, and a model for the PPI, which included 8th, 9th and 12th lags of the four principal components, as well as 1st, 3rd and 12th lags of the variable itself.

All calculations were performed using the Eviews econometric package.

INDUSTRIAL PRODUCTION AND RETAIL SALES

Industrial production

For making forecast for July to December 2020, the series of monthly data of the indexes of industrial production released by the Federal State Statistics Service (Rosstat) from January 2002 to April 2020, as well as the series of the base indexes of industrial production released by the National Research University Higher School of Economics (NRU HSE¹) over the period from January 2010 to May 2020 were used (the corrected value of January 2010 was equal to 100%). The forecast values of the series were calculated on the basis of ARIMA-class models. The forecast values of the Rosstat and the NRU HSE industrial production indexes are calculated using business surveys (BS) as well. The obtained results are shown in Table 1.

As seen from Table 1, the Rosstat average² decrease in the industrial production index in H2 2020 compared to the same period of the previous year for the industry as a whole comes to 3.7%. The NRU HSE industrial production index comes to 4.4%. The Rosstat and the NRU HSE IPI in July-December 2020 constitute 1.9% and 2.5%, respectively year-on-year.

The average monthly decline in the Rosstat and the NRU HSE industrial production indexes for mining and quarrying amount to 2.6% and 4.6%, respectively in July-December 2020.

The average decrease in the Rosstat industrial production index in manufacturing industry for H2 2020 amounts to 4.4% compared to the same period of the previous year and the NRU HSE industrial production index in manufacturing industry comes to 1.7%. The average monthly increase in production of food products to average by 3.5% and 3.5% for the Rosstat and the NRU HSE indexes, respectively. The production of coke and petroleum products is forecast to decline on average by 4.3% and 4.9% for the Rosstat and the NRU HSE indexes, respectively. The average monthly decline in the industrial production index for primary metals and fabricated metal products for July-December 2020 computed by Rosstat and the NRU HSE constitutes 7.2% and 8.9%, respectively. Manufacturing of machinery and equipment is forecast to drop on average by 4.8% and 3.4% for the Rosstat and the NRU HSE indexes, respectively.

The average gain in the Rosstat industrial production index for electricity, gas, and water supply; for air conditioning in H2 2020 constitutes 0.3% in comparison with the same period of the previous year; the same indicator the NRU HSE industrial production index comes to 0.3%.

Retail Sales

This section (Table 2) presents forecasts of monthly retail sales made on the basis of monthly Rosstat data over January 1999 – May 2020.

As seen from Table 2, the average forecast decrease in the monthly turnover for July-December 2020 against the corresponding period of 2019 amounts to around 3.4%. The average forecast drop in the monthly real turnover for the period July-December 2020 compared to the same period of 2019 constitutes 7.1%.

At an annualized rate, the projected decline in the retail turnover index in December 2020 in nominal terms comes to 1.0% and in real terms – 7%.

FOREIGN TRADE INDEXES

Model calculations of forecast values of the export, export to countries outside the CIS and the import, import from countries outside the CIS were made on the basis of the models of time series and structural models evaluated on the basis of the monthly data over the period from September 1998 to May 2020 on the basis of the data released by the Central Bank of Russia.¹ The results of calculations are presented in Table 3.

Export, import, export outside the CIS and import from the countries outside the CIS are forecast to decrease on average by 18.8%, 11.5%, 18.6%, and 12.7%, respectively for July-December 2020 against July-December 2019. The average forecast trade balance volume with all countries for July-December 2020 will total \$53.3 bn, which corresponds to a decrease by 31.6% in relation to July-December 2019.

DYNAMICS OF PRICES

The Consumer Price Index and Producer Price Index

This section presents calculations of forecast values of the consumer price index and producer price index (as regards both the industry in general and some types of its activities under the National Industry Classification Standard (NICS)) made on the basis of the time-series models evaluated on the basis of the data released by Rosstat over the period from January 1999 to April 2020.² Table 4 presents the results of model calculations of forecast values over July to December of 2020 in accordance with ARIMA-models, structural models (SM) and models computed with the help of business surveys (BS).

The forecast average monthly gain in the consumer price index in H2 2020 will come to 0.5%. The producer price index for industrial goods for the same period is forecast to average at -0.1% per month. At 2020-end, the forecast average inflation of consumer prices will come to 6.4% according to three models. The same index for producer price index will demonstrate a decline of 7.2%.

The Rosstat OKVED producer price indexes are forecast to grow at average monthly rate for July-December 2020: for mining and quarrying (-0.3%), for manufacturing (-0.4%), for utilities (electricity, gas, and water) 0.5%, for food products 1.1%, for textile and sewing industry 0.5%, for wood products 0.3%, for pulp and paper industry -0.1%, for coke and refined petroleum 2.5%, for chemical industry (-1.1%), for basic metals and fabricated metal products 1.0%, for machinery and equipment 0.5%, and for transport equipment manufacturing 0.5%.

The average decline in producer prices at 2020-end will come to 0.3%. The maximum drop is forecast in mining and quarrying at 34.3%. The maximum gain if forecast in primary metals and fabricated metal products at 21.2%.

The Cost of the Monthly per Capita Minimum Food Basket

This section presents calculations of forecast values of the cost of the monthly per capita minimum food basket over July to December 2020. The forecasts were made on the basis of time series with the use of the Rosstat data over the period from January 2000 to May 2020. The results are presented in Table 5.

DYNAMICS OF PRICES

As can be seen from *Table 5*, the minimum set of food products' cost is forecast to grow compared to the corresponding level of the previous year. Having said that, the minimum set of food products is forecast to average RUB 4,331.2. The minimum set of food products' cost is forecast to grow on average at around 5.5% against the same period of last year. The annual gain in the minimum set of food products will amount to 4.9% in December 2020.

Indexes of Freight Rates

This section presents calculations of forecast values of freight tariff indexes on cargo carriage,¹ made on the basis of time-series models evaluated on the Rosstat data over the period from September 1998 to April 2020. Table 6 shows the results of model calculations of forecast values in the July-December of 2020. It should be noted that some of the indexes under review (for instance, the index of pipeline tariff) are adjustable ones and for that reason their behavior is hard to describe by means of the time-series models. As a result, the future values may differ greatly from the real ones in case of the centralized increase in tariffs in the period of forecasting or in case of absence of such an increase in the forecasting period, but with it taking place shortly before the beginning of that period.

According to the forecast results for July-December 2020, the composite index of transport tariffs on freight carriage during six months under review will be declining at an average monthly rate of -0.1%. In July 2020, the seasonal growth in the index is expected at 3.4 p.p. and in October a seasonal decline at -4.3 p.p. As a result, its annual growth in 2020 will come to 3.8%.

The index of motor freight tariffs will be decreasing during these six months at an average monthly rate of 0.6%. Its annual decline is forecast at 7.5% in 2020.

The index of pipeline tariffs will be growing at an average monthly rate of 0.6%. In July 2020, the seasonal growth in the index is expected at 2.8 p.p. As a result, its annual gain will come to 1.7% in 2020.

World Prices of Natural Resources

This section presents calculations of such average monthly values of Brent crude prices (US\$ per barrel), the aluminum prices (US\$ per ton), the gold prices (\$ per ounce), the copper prices (US\$ per ton), and the nickel prices (US\$ per ton) over June to November 2020 as were received on the basis of nonlinear models of time series evaluated on the basis of the IMF data over the period from January 1980 to May 2020.

The crude oil price is forecast to average around \$33.6 per barrel, which is below its corresponding year-earlier indexes on average by 46.2%. The alu-

minum prices are forecast to average around \$1,488 per ton and their average forecast decline constitutes around 15% compared to the same level of last year. The gold price is forecast to average \$1,767 per ounce. The copper price is forecast to average \$5,639 per ton, and prices for nickel – around \$12,446 per ton. The average forecast price increase in gold constitutes around 20%, the average decline in copper prices – around 4%, nickel prices – 20% against the corresponding level of last year.

At 2020-end, the forecast decrease in prices on oil, aluminum, copper, and nickel compared to the end of 2019 will come to 49.8, 17.0, 7.4 and 11.1%, respectively. The projected increase in gold prices – 21.8%.

MONETARY INDEXES

The future values of the monetary base (in the narrow definition: cash funds and the Fund of Mandatory Reserves (FMR) and M_2 monetary aggregate over the period from July to December 2020 were received on the basis of models of time-series of respective indexes calculated by the CBR¹ in the period from October 1998 to June 2020 for the monetary base and to April 2020 for M_2 monetary. Table 8 presents the results of calculations of forecast values and actual values of those indexes in the same period of previous year. It is to be noted that due to the fact that the monetary base is an instrument of the CBR policy, forecasts of the monetary base on the basis of time-series models are to a certain extent notional as the future value of that index is determined to a great extent by decisions of the CBR, rather than the inherent specifics of the series.

In July-December 2020, the monetary base in the period under review will be growing at an average monthly rate of 0.8%. According to projections, the annual gain of the monetary base will come to 23.2% in 2020. In the period under review, M_2 monetary index will be growing at an average monthly rate of 0.2%. The annual increment of M_2 index is projected at 7.6% in 2020.

INTERNATIONAL RESERVES

INTERNATIONAL RESERVES

This section presents the outputs of the statistical estimation of such future values of the international reserves of the Russian Federation¹ as were received on the basis of evaluation of the model of time series of the gold and foreign exchange reserves on the basis of the data released by the CBR over the period from October 1998 to June of 2020. That index is forecast without taking into account a decrease in the amount of reserves due to foreign debt payment and for that reason the values of the volumes of the international reserves in the months where foreign debt payments are made may happen to be overestimated (or otherwise underestimated) as compared to the actual ones.

Subsequent to the forecast findings for July-December 2020, the international reserves will be growing at an average monthly rate of 0.5%. In 2020, the international reserves will grow at 7.5%.

FOREIGN EXCHANGE RATES

The model calculations of prospective values of the foreign exchange rates (RUB per USD and USD per euro) were made on the basis of assessment of the time series models (ARIMA) and structural models (SM) of the relevant indicators released by the Central Bank of Russia as of the last date of each month over the periods from October 1998 to June 2020 and from February 1999 to June 2020,² respectively.

In July-December 2020, USD/RUB average exchange rate is forecast according to two models in the amount of RUB 72.18 per USD. The projected index will come to RUB 72.86 per USD on average according to two models at 2020-end.

Projected Euro/USD exchange rate over the period under review will average USD 1.12 per 1 euro. At 2020-end, the projected index will stay at USD 1.12 per 1 euro.

THE LIVING STANDARD INDEXES

This section (Table 11) presents results of calculations of monthly forecast values of index of real wages, as well as quarterly forecast values of real disposable cash income and real cash income¹ as were obtained on the basis of models of time series of respective indexes computed by Rosstat and taken over the period from January 1999 to March 2020, as well as from Q1 2014 to Q1 2020. The above indexes depend to a certain extent on the centralized decisions on raising of wages and salaries to public sector workers, as well as those on raising of pensions, scholarships, and allowances; such a situation introduces some changes in the dynamics of the indexes under review. Consequently, the future values of the indexes of real wages and real disposable cash income calculated on the basis of the series which last observations are either considerably higher or lower than the previous ones due to such a raise may differ greatly from those which are implemented in reality.

The results presented in Table 11, project growth in real wages. The real wages are expected to gain on average 7.2% compared to the same period of the previous year.

At the end of 2020, the projected increment of real wages will come to 3.6% for 12 months.

The results presented in Table 12 project average quarterly decrease in real disposable cash income by 0.5%. The forecast average gain in real cash income will be 0.4% compared to the corresponding period of the last year.

At the end of 2020, the projected decrease in real disposable cash income will come to 2%; decrease in real cash income will be 1.4% for 12 months.

EMPLOYMENT AND UNEMPLOYMENT

EMPLOYMENT AND UNEMPLOYMENT

For the purpose of calculation of the future values of employment (the number of gainfully employed population) and the unemployment (the total number of unemployed), models of the time series evaluated over the period from October 1998 to April 2020 on the basis of the monthly data released by Rosstat¹ were used. The unemployment was calculated on the basis of the models with results of the findings from business surveys² too.

It is to be noted that feasible logical inconsistencies³ in forecasts of employment and unemployment which totals should be equal to the index of gainfully employed population may arise due to the fact that each series is forecast individually and not as a difference between the forecast values of gainfully employed population and another index.

According to ARIMA-model forecast (*Table 13*), in July-December 2020, the decrease in the number of employed in the economy will average 0.8% per month against the corresponding period of the previous year. At 2020-end, the projected number of employed in the economy will come to 71.7 mn.

The average increase in the total number of unemployed is forecast at 27.1% per month against the same period of last year. The average number of jobless at 2020-end is projected at 4.4 mn.

Fig. 1a. The Rosstat industrial production index (ARIMA-model) (% of December 2001)

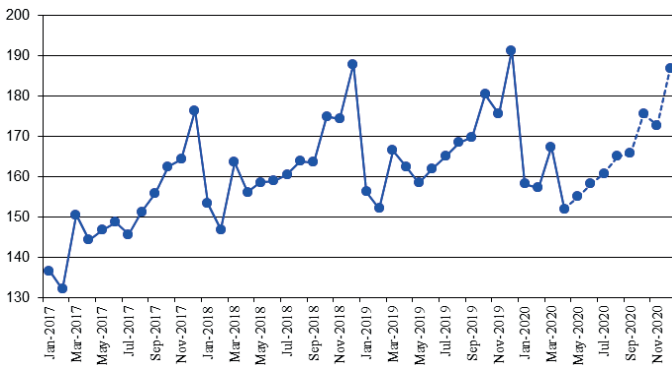


Fig. 1b. The NRU HSE industrial production index (ARIMA-model) (% of January 2010)

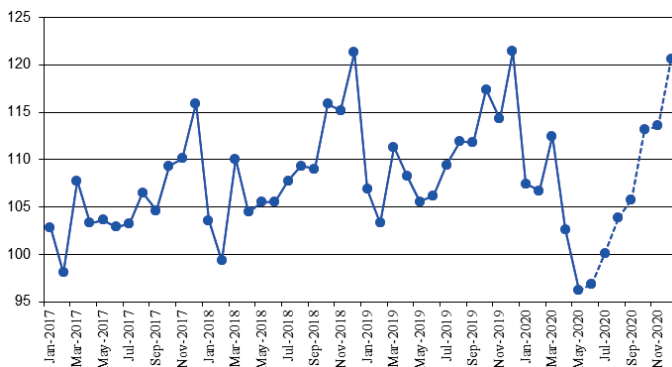


Fig. 2a. The Rosstat industrial production index for mining (% of December 2001)

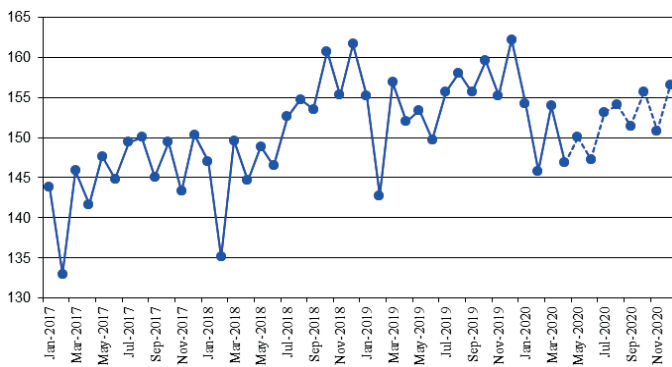
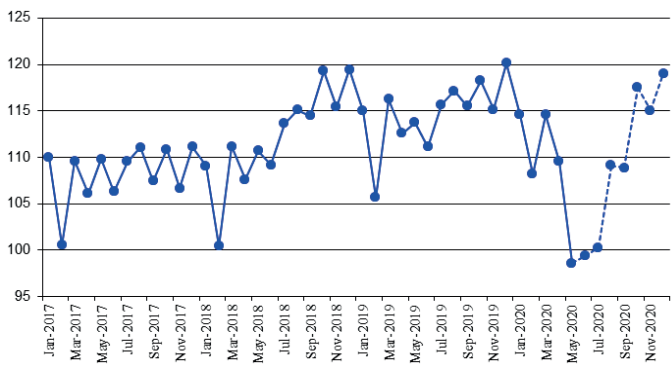


Fig. 2b. The NRU HSE industrial production index for mining (% of January 2010)

Fig. 3a. The Rosstat industrial production index for manufacturing (% of December 2001)

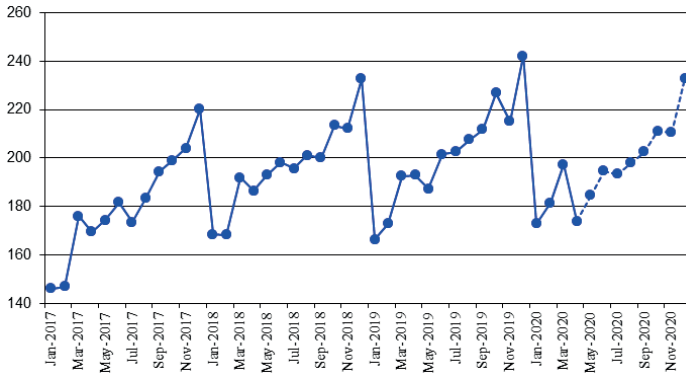


Fig. 3b. The NRU HSE industrial production index for manufacturing (% of January 2010)

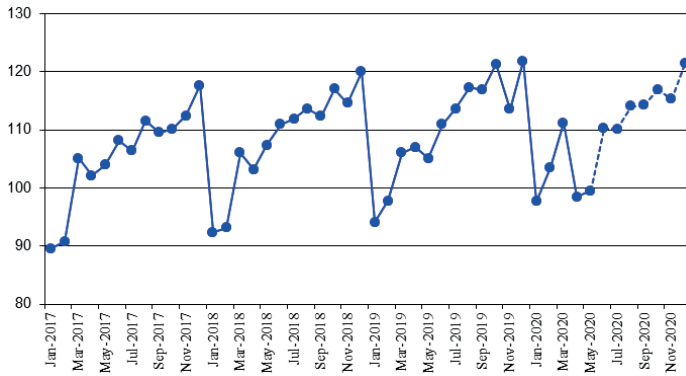


Fig. 4a. The Rosstat industrial production index for utilities (electricity, water, and gas) (as a percentage of that in December 2001)

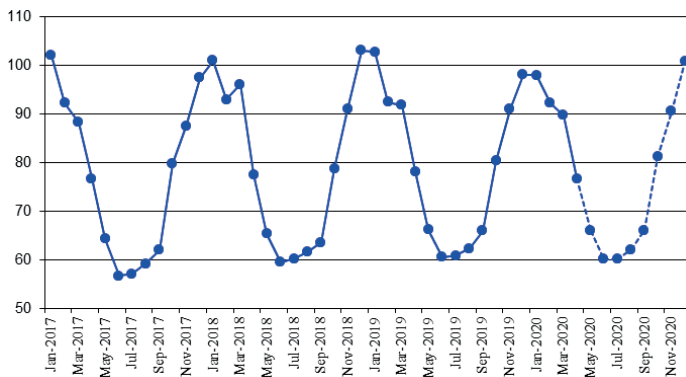
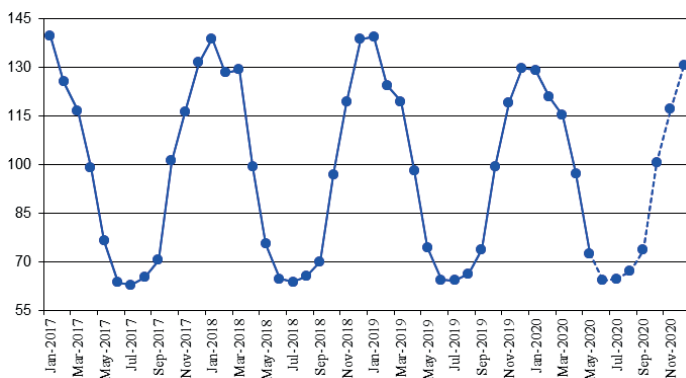


Fig. 4b. The NRU HSE industrial production index for utilities (electricity, water, and gas) (as a percentage of that in January 2010)

Fig. 5a. The Rosstat industrial production index for food products (as a percentage of that in December 2001)

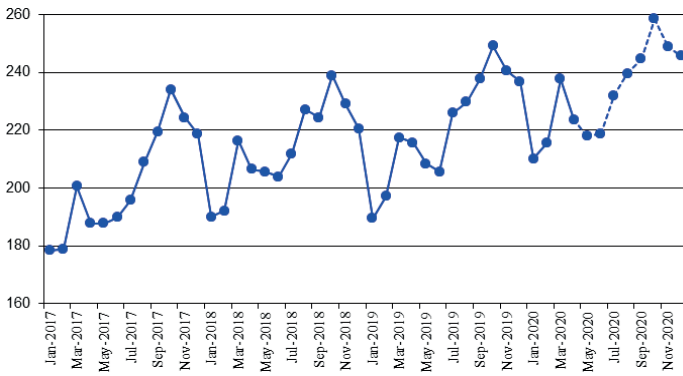


Fig. 5b. The NRU HSE industrial production index for food products (as a percentage of that in January 2010)

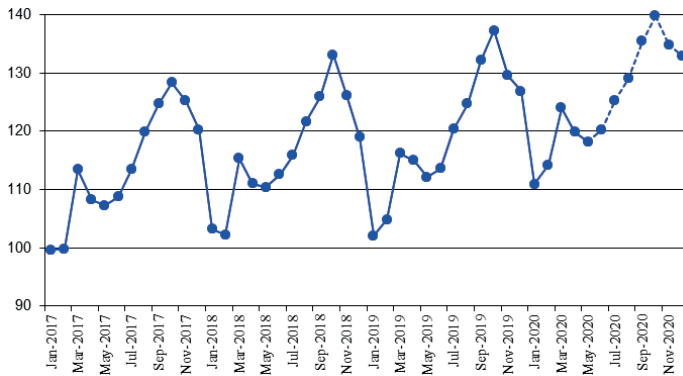


Fig. 6a. The Rosstat industrial production index for coke and petroleum (as a percentage of that in December 2001)

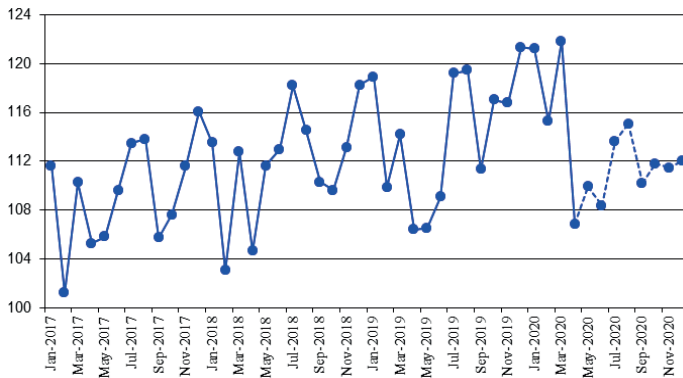
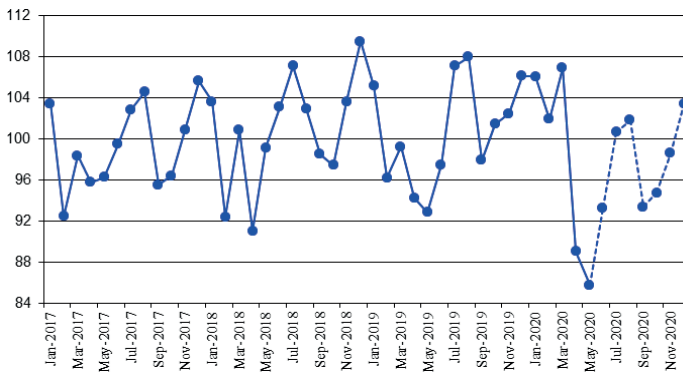


Fig. 6b. The NRU HSE industrial production index for petroleum and coke (as a percentage of that in January 2010)

Fig.7a. The Rosstat industrial production index for primary metals and fabricated metal products (as a percentage of that in December 2001)

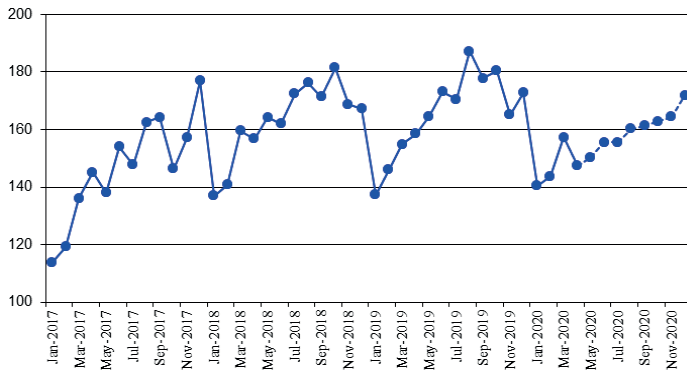


Fig. 7b. The NRU HSE industrial production index for primary metals and fabricated metal products (as a percentage of that in January 2010)

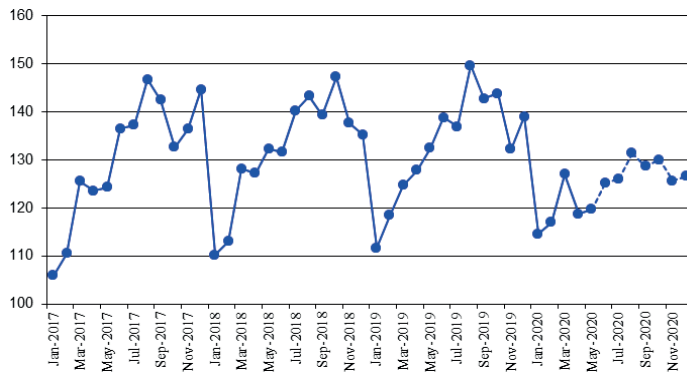


Fig. 8a. The Rosstat industrial production index for machinery (as a percentage of that in December 2001)

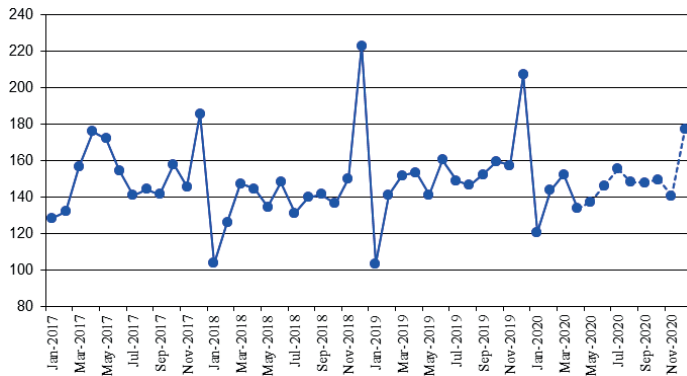
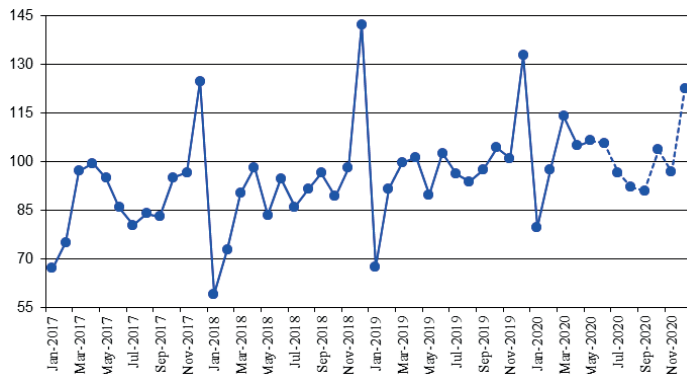


Fig. 8b. The NRU HSE industrial production index for machinery (as a percentage of that in January 2010)

Fig. 9. The volume of retail sales (billion RUB)

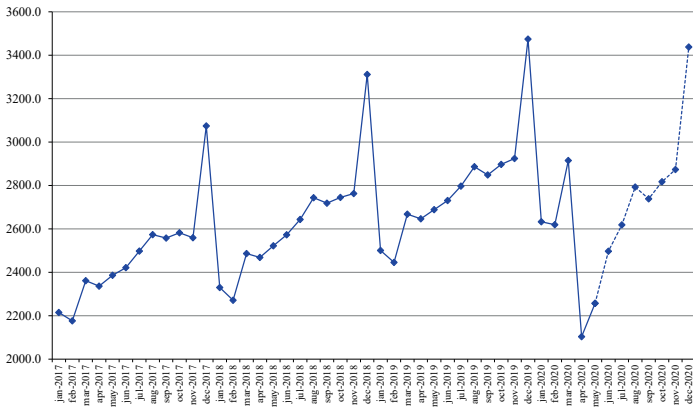


Fig. 9a. The real volume of retail sales (as a percentage of that in the same period of the previous year)

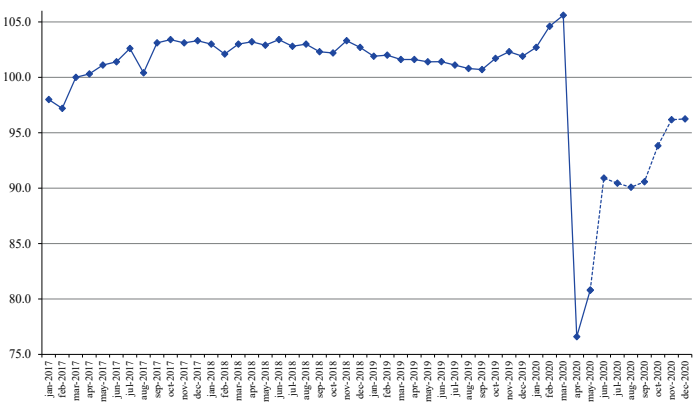


Fig.10. Export to all countries (billion USD)

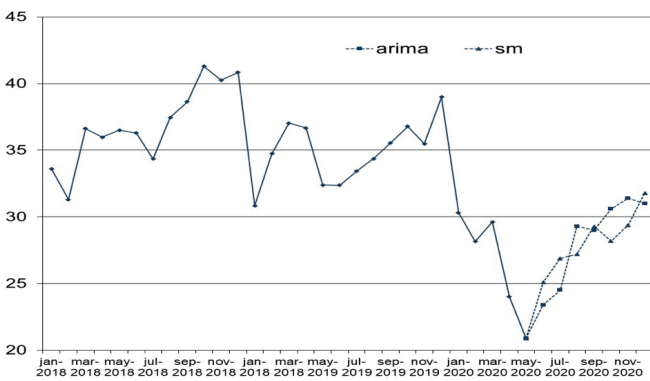
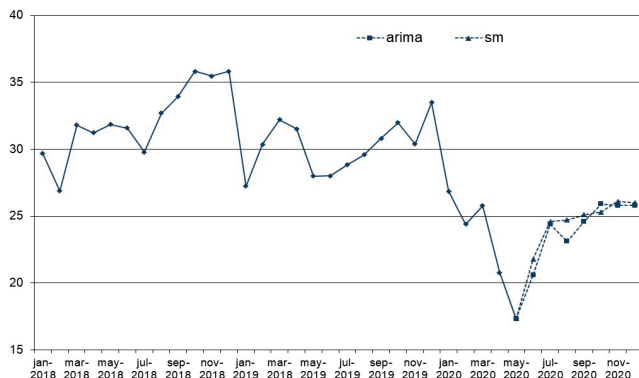


Fig. 11. Export to countries outside the CIS (billion USD)

Fig. 12. Import from all countries (billion USD)

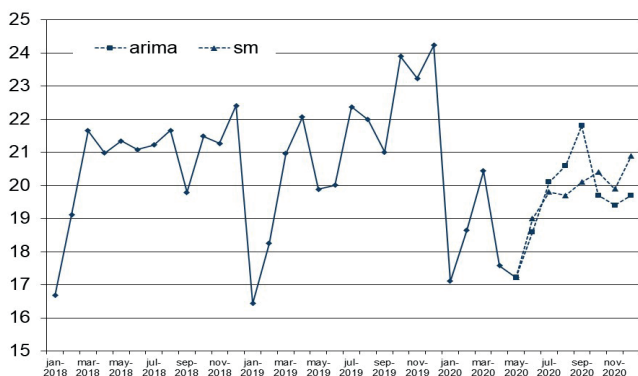


Fig. 13. Import from countries outside the CIS (billion USD)

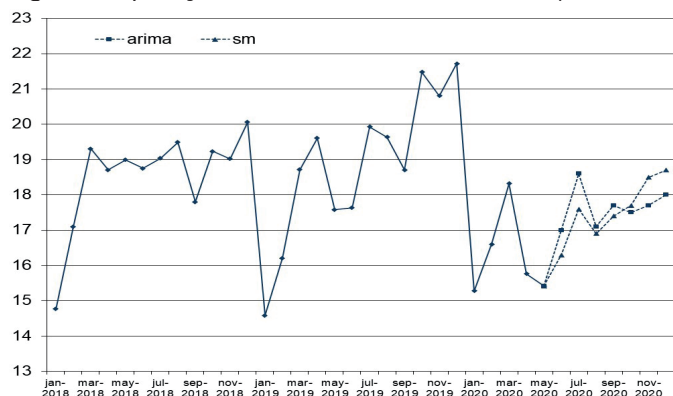


Fig. 14. The consumer price index (as a percentage of that in December of the previous year)

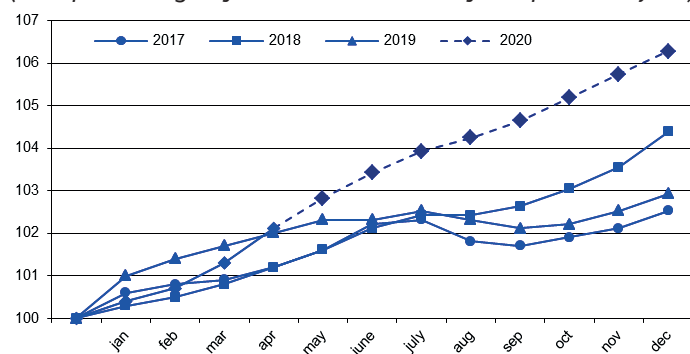
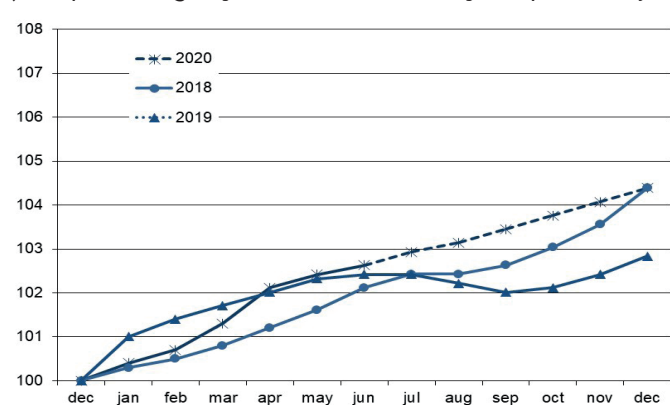


Fig. 14a. The consumer price index (as a percentage of that in December of the previous year) (SM)

Fig.15. The producer price index for industrial goods (as a percentage of that in December of the previous year)

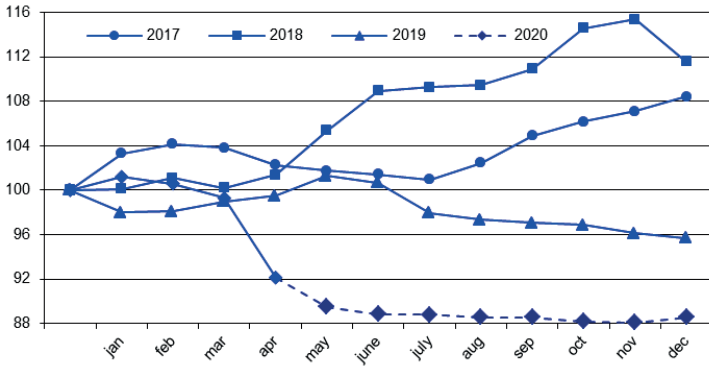


Fig. 16. The price index for mining (as a percentage of that in December of the previous year)

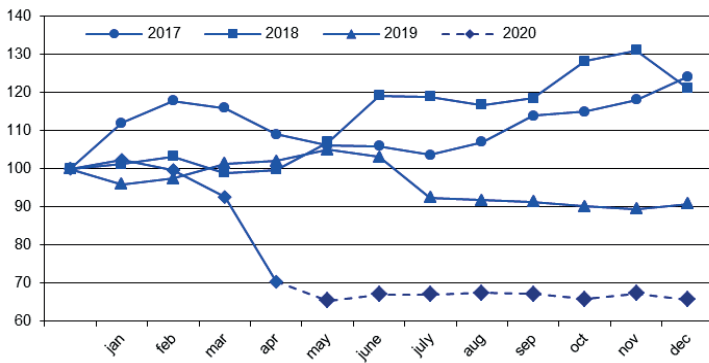


Fig. 17. The price index for manufacturing (as a percentage of that in December of the previous year)

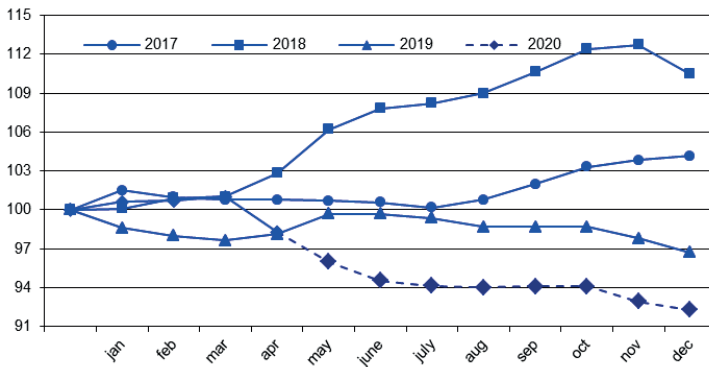
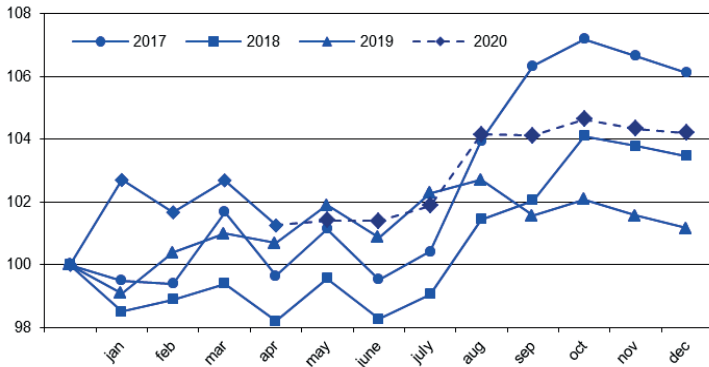


Fig. 18. The price index for utilities (electricity, water, and gas) (as a percentage of that in December of the previous year)

Fig. 19. The price index for food products (as a percentage of that in December of the previous year)

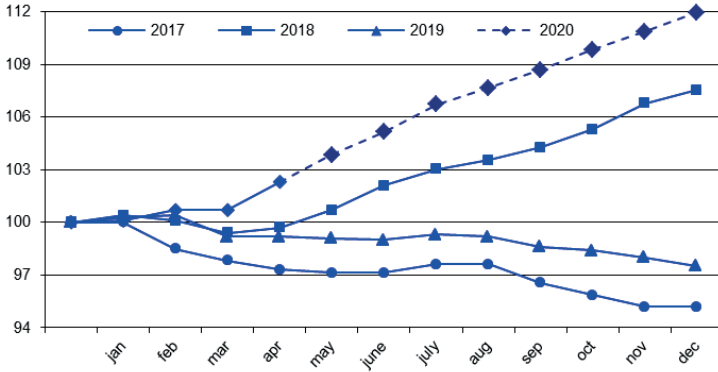


Fig. 20. The price index for the textile and sewing industry (as a percentage of that in December of the previous year)

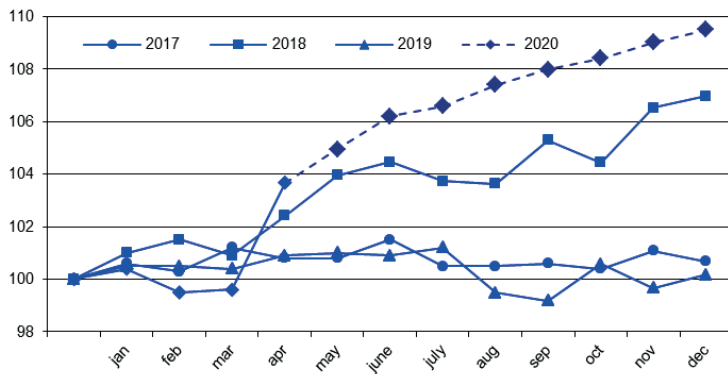


Fig. 21. The price index for wood products (as a percentage of that in December of the previous year)

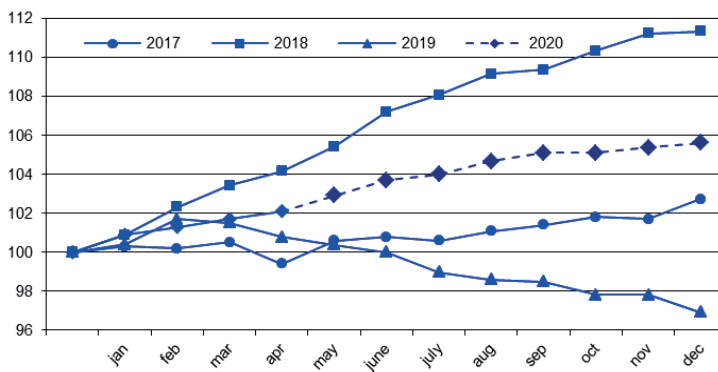
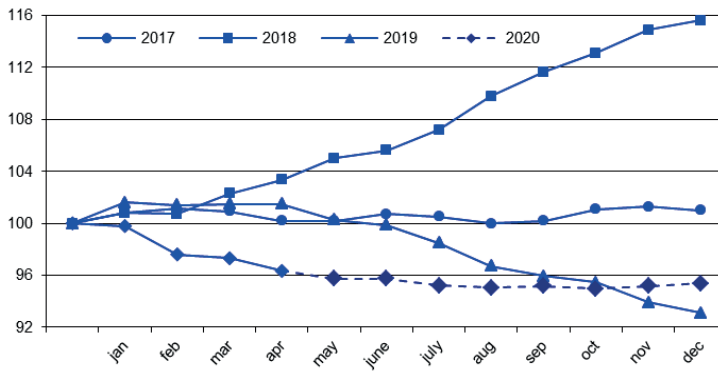


Fig. 22. The price index for the pulp and paper industry (as a percentage of that in December of the previous year)

Fig. 23. The price index for coke and petroleum (as a percentage of that in December of the previous year)

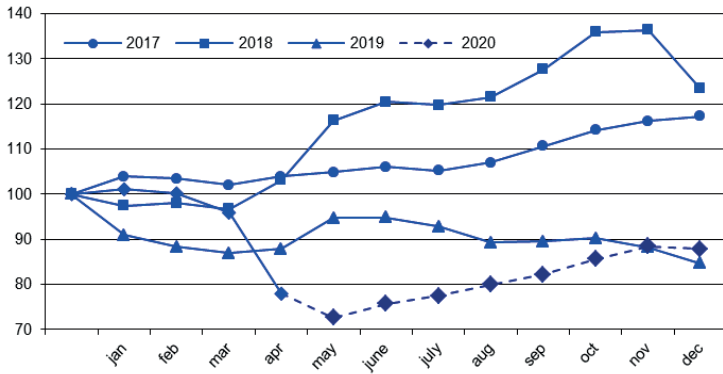


Fig. 24. The price index for the chemical industry (as a percentage of that in December of the previous year)

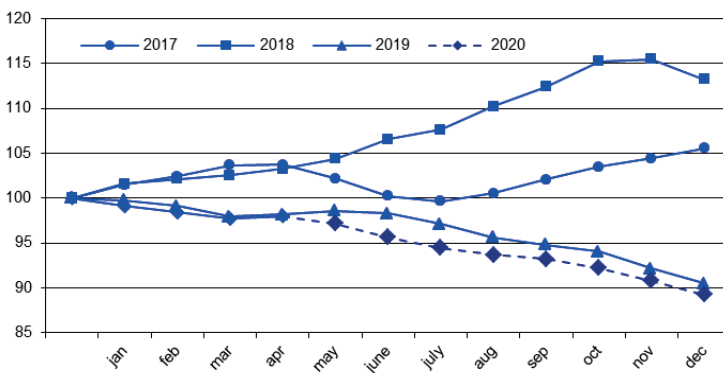


Fig. 25. The price index for primary metals and fabricated metal products (as a percentage of that in December of the previous year)

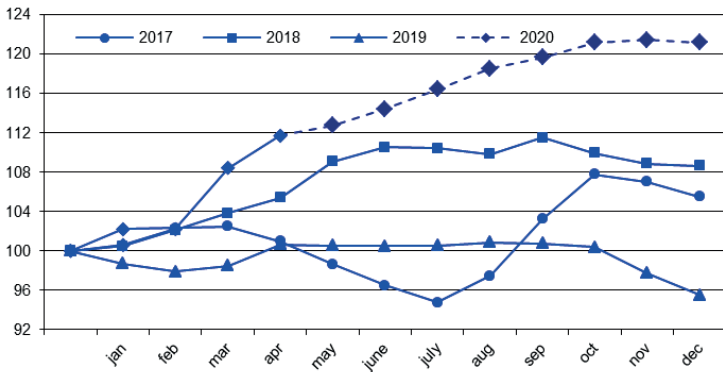
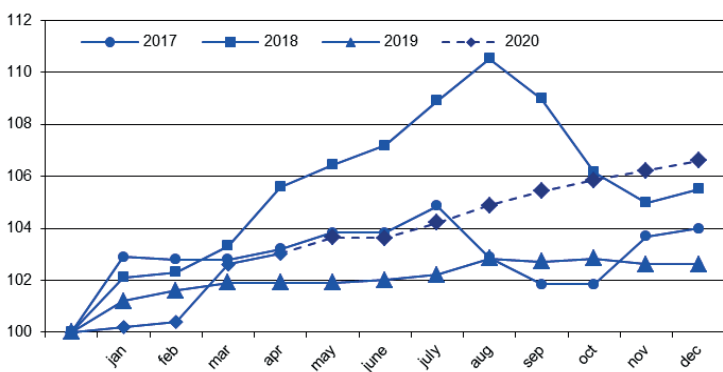


Fig. 26. The price index for machinery (as a percentage of that in December of the previous year)

Fig. 27. The price index for transport equipment manufacturing (as a percentage of that in December of the previous year)

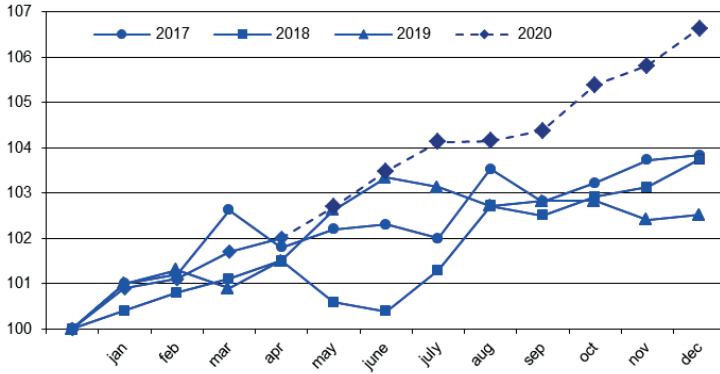


Fig. 28. The cost of the monthly per capita minimum food basket (RUB)

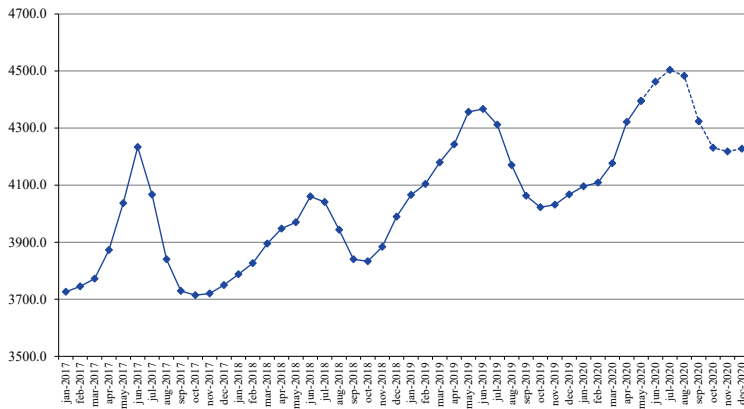


Fig. 29. The composite index of transport tariffs (for each year, as a percentage of that in the previous month)

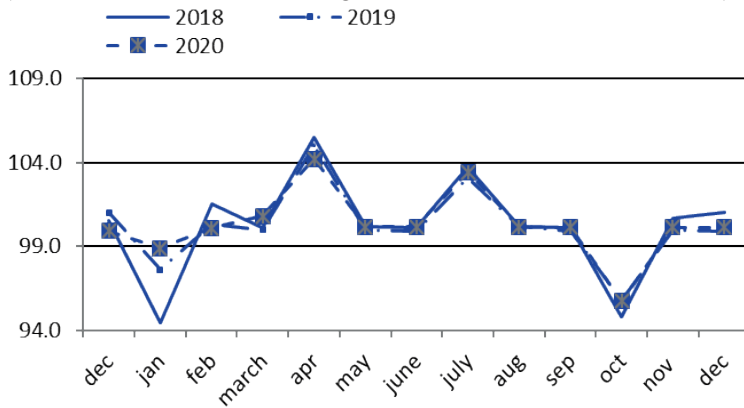
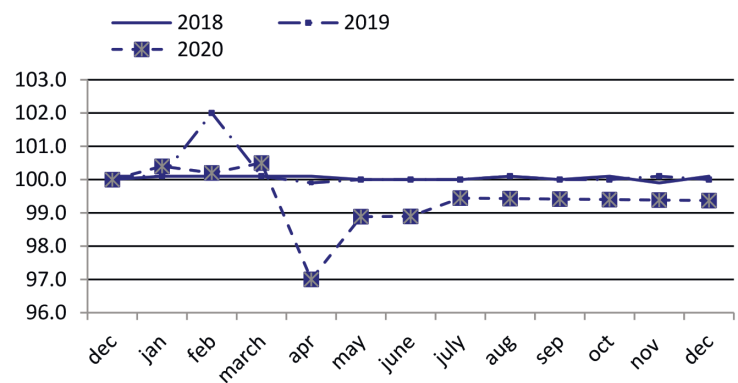


Fig. 30. The index of motor freight tariffs (for each year, as a percentage of that in the previous month)

Fig. 31. The index of pipeline tariffs (for each year, as a percentage of that in the previous month)

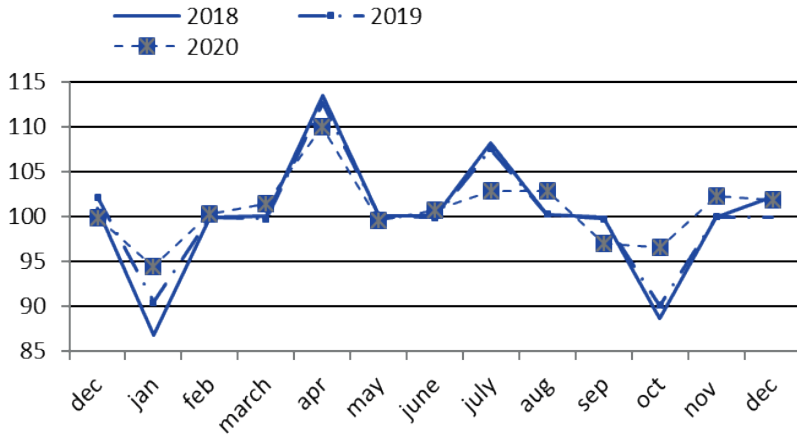


Fig. 32. The Brent oil price (\$ per barrel)

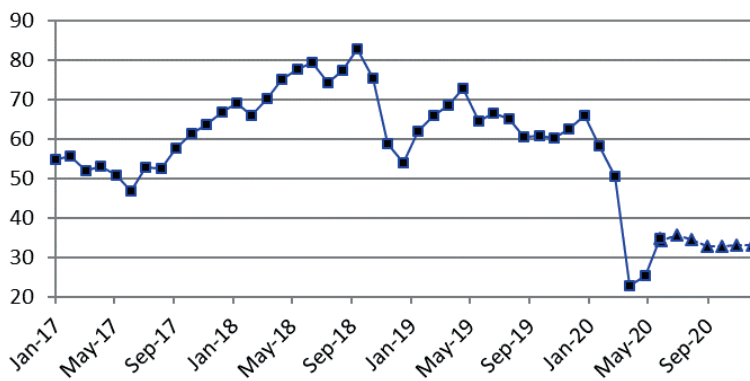


Fig. 33. The aluminum price (\$ per ton)

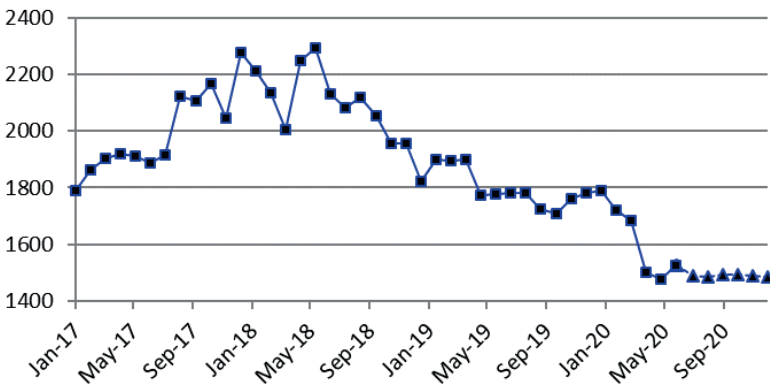
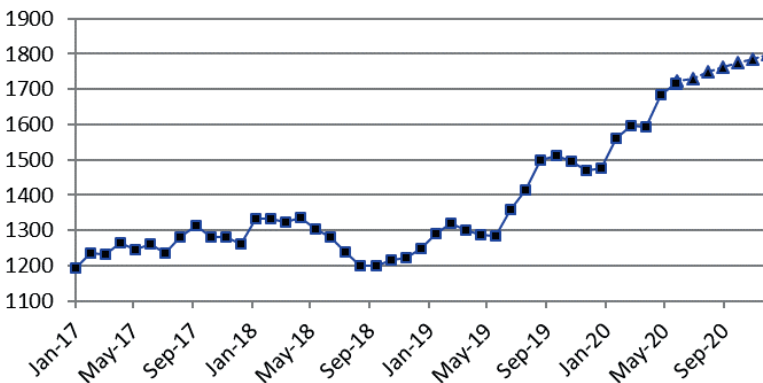


Fig. 34. The gold price (\$ per ounce)

Fig. 37. The monetary base, billion RUB

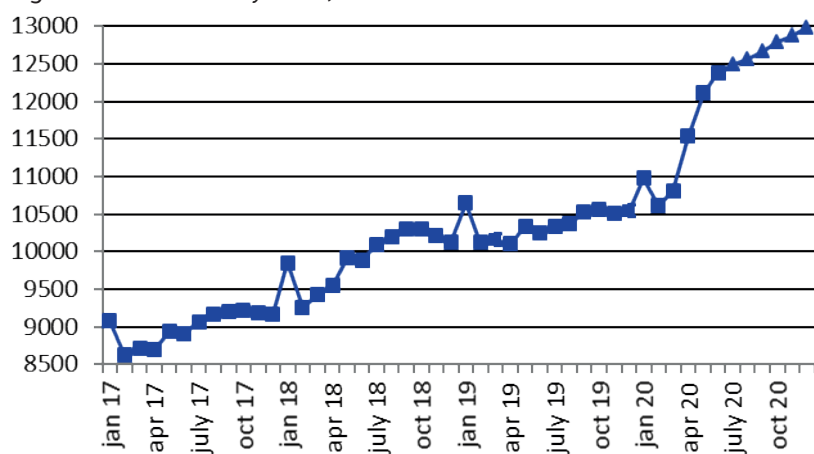
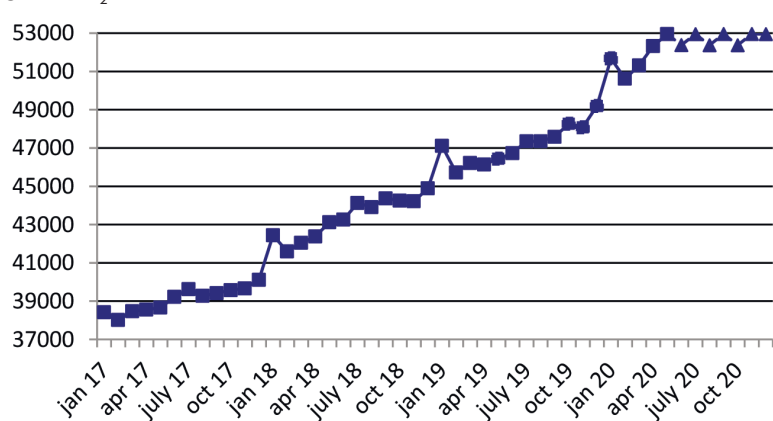


Fig. 38. M_2 , billion RUB

Fig. 39. The international reserves of the Russian Federation, million USD

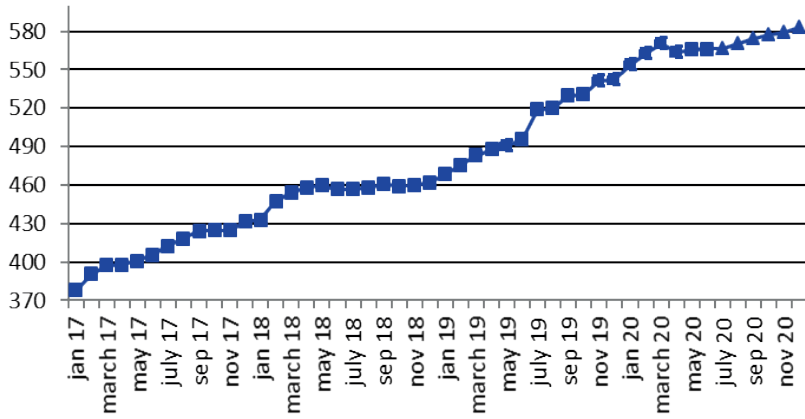


Fig. 40. The RUB/USD exchange rate

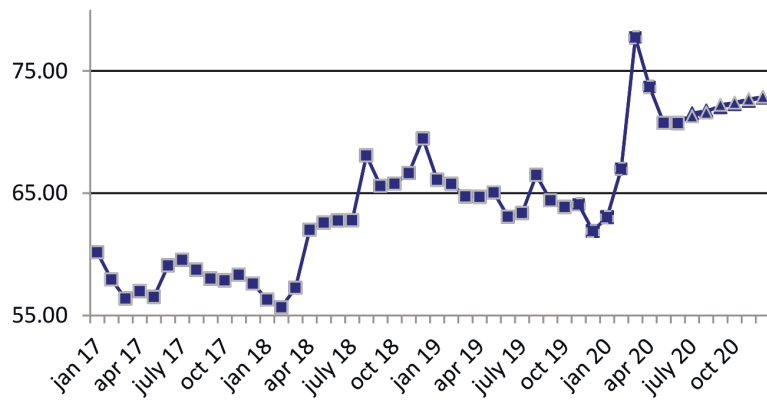


Fig. 41. The USD/EUR exchange rate

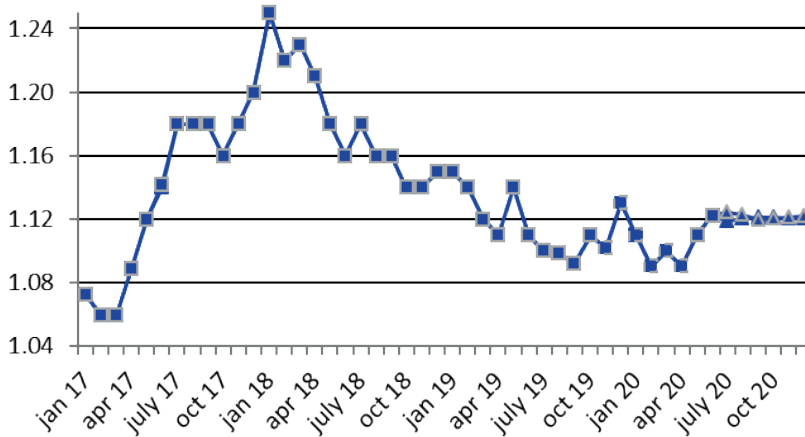
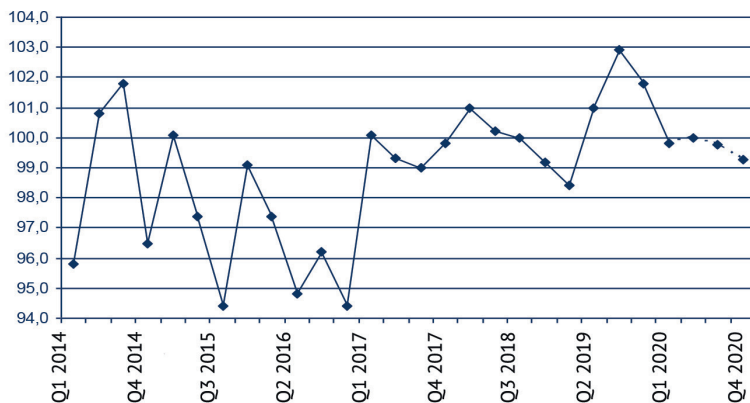


Fig. 42. Real disposable cash income (as a percentage of that in the same period of the previous year)

(as a percentage of that in the same period of the previous year)

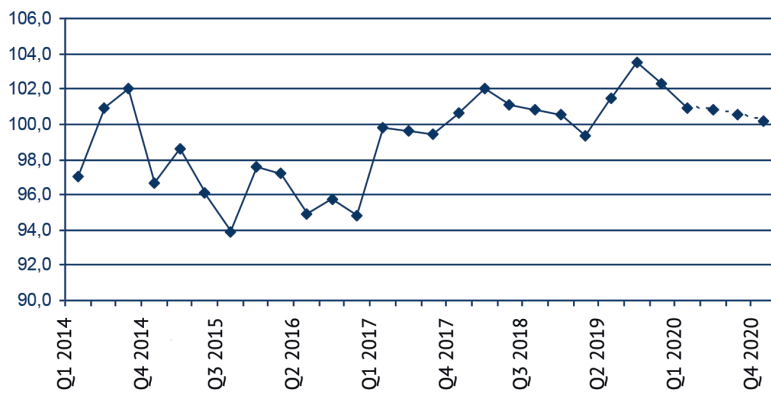


Fig. 44. Real accrued wages
(as a percentage of those in the same period of the previous year)

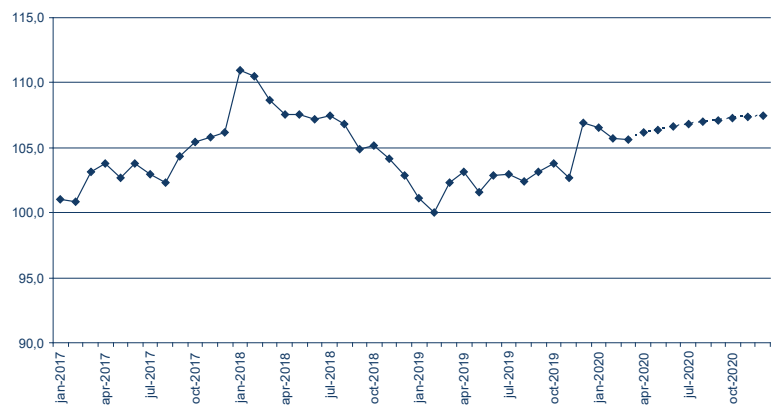


Fig. 45. Employment (million people)

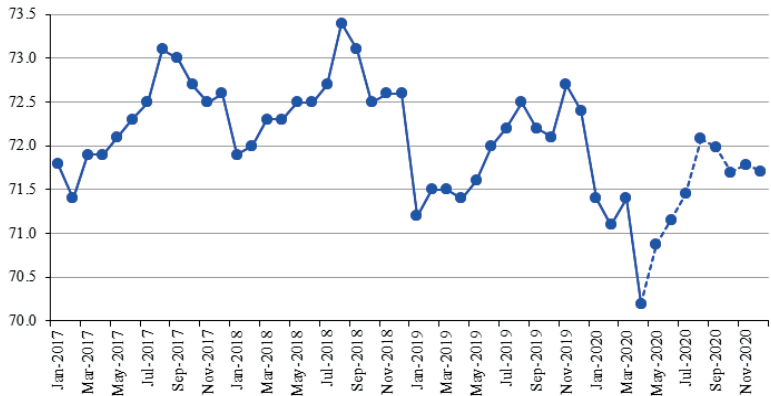
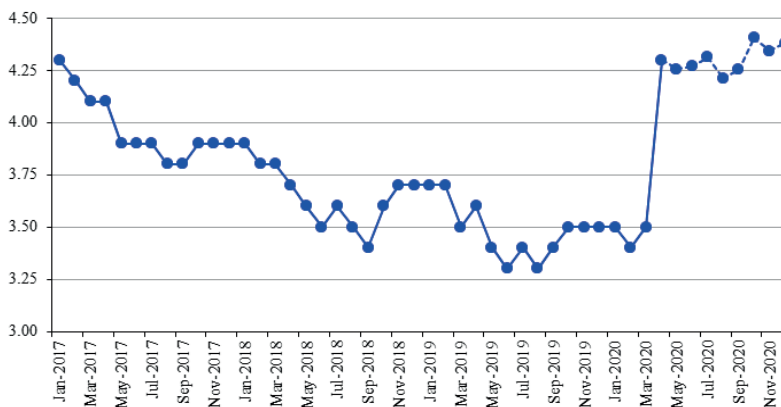


Fig. 46. Unemployment (million people)
