## INTRODUCTION TO ALL THE ISSUES

This paper presents calculations of various economic indicators for the Russian Federation in *the second half* of 2018, which were performed using time series models developed as a result of research conducted by the Gaidar Institute over the past few years<sup>1</sup>. A method of forecasting falls within the group of *formal* or *statistical* methods. In other words, the calculated values neither express the *opinion* nor *expert evaluation* of the researcher, rather they are calculations of future values for a specific economic indicator, which were performed using formal ARIMA models ( $p, d, q$ ) given a prevailing trend and its, in some cases, significant changes. The presented forecasts are of inertial nature, because respective models rely upon the dynamics of the data registered prior to the moment of forecasting and depend too heavily on the trends, which are typical of the time series in the period immediately preceding the time horizon to be forecast. The foregoing calculations of future values of economic indicators for the Russian Federation can be used in making decisions on economic policy, provided that the general trends, which were seen prior to forecasting for each specific indicator, remain the same, i.e. prevailing long-term trends will see no serious shocks or changes in the future.

Despite that there is a great deal of data available on the period preceding the crisis of 1998, models of forecasting were analyzed and constructed using only the time horizon which followed August 1998. This can be explained by the findings of previous studies<sup>2</sup>, which concluded, among other key inferences, that the quality of forecasts was deteriorated in most of the cases when the data on the pre-crisis period was used. Additionally, it currently seems incorrect to use even shorter series (following the crisis of 2008), because statistical characteristics of models based on such a short time horizon are very poor.

Models for the economic indicators in question were evaluated using standard methods of time series analysis. Initially, the correlograms of the studied series and their first differences were analyzed in order to determine the maximum number of delayed values to be included into the specifications of a model. Then, the results of analyzed correlograms served as the basis for testing all the series for weak stationarity (or stationarity around the trend) using the Dickey–Fuller test. In some cases, the series were tested for stationarity around the segmented trend using Perron and Zivot–Andrews tests for endogenous structural changes<sup>3</sup>.

The series were broken down into weak stationary, stationary near the trend, stationary near the trend with structural change or difference stationary, and then models, which corresponded to each type (regarding the levels and including, if necessary, the trend or segmented trend or differences), were evaluated. The Akaike and Schwartz information criteria, the properties of models' residuals (lack of autocorrelation, homoscedasticity and normality) and the quality of the in-sample-forecasts based on these models were used to choose the best model. Forecast values were calculated for the best of the models constructed for each economic indicator.

Additionally, the Bulletin presents future monthly values of the CPI, which were calculated using models developed at the Gaidar Institute, and volumes of imports/exports from/to all countries, which were calculated using structural models (SM). The forecast values based on the structural models may, in some cases, produce better results than ARIMA-models do, because structural models are constructed by adding information of the dynamics of exogenous variables. Besides,

the use of structural forecasts in making aggregated forecasts (i.e. forecasts obtained as average value from several models) may help make forecast values more accurate.

The dynamics of the Consumer Price Index was modeled using theoretical assumptions arising from the monetary theory. The following was used as explanatory variables: money supply, output volume, the dynamics of the ruble-dollar exchange rate, which reflects the dynamics of alternative cost of money-keeping. The model for the Consumer Price Index also included the price index in the electric power industry, because the dynamics of manufacturers' costs relies heavily on this indicator.

The baseline indicator to be noted is the real exchange rate, which can influence the value of exports and imports, and its fluctuations can result in changes to the relative value of domestically-produced and imported goods, though the influence of this indicator turns out to be insignificant in econometric models. Global prices of exported resources, particularly crude oil prices, are most significant factors, which determine the dynamics of exports: a higher price leads to greater exports of goods. The level of personal income in the economy (labor costs) was used to describe the relative competitive power of Russian goods. Fictitious variables D12 and D01 – equal to one in December and January and zero in other periods – were added so that seasonal fluctuations were factored in. The dynamics of imports is effected by personal and corporate incomes whose increase triggers higher demand for all goods including imported ones. The real disposable cash income reflects the personal income; the Industrial Production Index reflects the corporate income.

The forecast values of foreign exchange rates were also calculated using structural models of their dependence on global crude oil prices.

The forecast values of explanatory variables, which are required for forecasting on the basis of structural models, were calculated using ARIMA models ( $p, d, q$ ).

The paper also presents calculations of the values of the Industrial Production Index, the Producer Price Index and the Total Unemployment Index, which were calculated using the results of business surveys conducted by the Gaidar Institute. Empirical studies show<sup>1</sup> that the use of series of business surveys as explanatory variables<sup>2</sup> in forecasting models can make forecasting more accurate on the average. Future values of these indicators were calculated using ADL-models (seasonal autoregressive delays were added).

The Consumer Price Index and the Producer Price Index are also forecast using large datasets (factor models – FM). The construction of factor models relies basically on the evaluation of the principal components of a large dataset of socio-economic indicators (112 indicators in this case). The lags of these principal components and the lags of the explanatory variable are used as explanatory variables in these models. A quality analysis of the forecasts obtained for different configurations of the factor models was used to choose a model for the CPI, which included 9<sup>th</sup>, 12<sup>th</sup> and 13<sup>th</sup> lags of the four principal components, as well as 1<sup>st</sup> and 12<sup>th</sup> lags of the variable itself, and a model for the PPI, which included 8<sup>th</sup>, 9<sup>th</sup> and 12<sup>th</sup> lags of the four principal components, as well as 1<sup>st</sup>, 3<sup>rd</sup> and 12<sup>th</sup> lags of the variable itself.

All calculations were performed using the Eviews econometric package.

## INDUSTRIAL PRODUCTION AND RETAIL SALES

### Industrial production

For making forecast for July-December of 2018, the series of monthly data of the indexes of industrial production released by the Federal State Statistics Service (Rosstat) from January 2002 April 2018, as well as the series of the base indexes of industrial production released by the National Research University Higher School of Economics (NRU HSE<sup>1</sup>) over the period from January 2010 to May 2018 were used (the corrected value of January 2010 was equal to 100%). The forecast values of the series were calculated on the basis of ARIMA-class models. The forecast values of the Rosstat and the NRU HSE indexes of industrial production are calculated using business surveys (BS) as well. The obtained results are shown in Table 1.

As seen from Table 1, the Rosstat average<sup>2</sup> growth of industrial production index posted 2.6% in H2 2018 compared to the same period of the previous year for industry as a whole. As for the NRU HSE industrial production index, this indicator constitutes 1.7%. At 2018-end, forecast growth of the Rosstat industrial production index will constitute 2.8%, and the NRU HSE industrial production index – 1.7%.

The average monthly increase of the Rosstat industrial production index and for the NRU HSE industrial production index for mining for July-December 2018 comes to 1.0% and 1.2%, respectively.

In H2 2018 in comparison with the same period of last year, the average growth of the Rosstat industrial production index for manufacturing comes to 5.0% and the NRU HSE industrial production index to 5.9%. The average monthly growth of the Rosstat industrial production index and the NRU HSE industrial production index for food products constitute 3.6% and 3.1%, respectively. The production of coke and petroleum products is forecast to grow 1.8% and 0.0% for the Rosstat and NRU HSE indexes, respectively. The average monthly change of the industrial production index for primary metals and fabricated metal products for July-December 2018 computed by Rosstat and the NRU HSE constitute 4.1% and 2.2%, respectively. Manufacturing of machinery and equipment is forecast to increase by 4.9% and 6.5% for the Rosstat and the NRU HSE indexes, respectively.

The average growth of the industrial production index for electricity, gas, and steam supply; for air conditioning computed by Rosstat for H2 2018 in comparison with the same period of the previous year constitutes 1.3%; the same indicator for the NRU HSE industrial production index comes to 1.2%.

### Retail Sales

This section (Table 2) presents forecasts of monthly retail sales made on the basis of monthly Rosstat data over January 1999 – May 2018.

As seen from Table 2, the monthly trade turnover is forecast to grow on average at around 4.3% in July-December 2018 against the corresponding period of 2017. The average monthly real trade turnover is forecast to grow at around 3.4% for the forecast period. Retail trade turnover will growth by 4.2% and real – by 3.0% at the annual rate.

### FOREIGN TRADE INDEXES

*Model calculations of forecast values of the export and export to countries outside the CIS and the import and import from countries outside the CIS were made on the basis of the models of time series and structural models evaluated on the basis of the monthly data over the period from September 1998 to May 2018 on the basis of the data released by the Central Bank of Russia<sup>1</sup>. The results of calculations are shown in Table 3.*

Export, import, export outside the CIS and import from the countries outside the CIS are forecast to grow on average at 26.1%, 20.2%, 30.4%, and 23.2%, respectively in July-December 2018 against the same period of 2017. The average forecast surplus volume of the trade balance with all countries for July-December 2018 will amount to \$ 166.2bn which reflects increase of 44.5% on the same period of 2017.

### DYNAMICS OF PRICES

#### **The Consumer Price Index and the Producer Price Index**

*This section presents calculations of forecast values of the consumer price index and the producer price index (as regards both the industry in general and some types of its activities under the National Industry Classification Standard (NICS)) made on the basis of the time-series models evaluated on the basis of the data released by Rosstat over the period from January 1999 to April 2018<sup>2</sup>. Table 4 presents the results of model calculations of forecast values over July-December of 2018 in accordance with ARIMA models, structural models (SM) and models computed with the help of business surveys (BS).*

The consumer price index is forecast to grow at an average monthly rate of 0.3% in H2 2018. The producer price index (PPI) for the same period is also forecast to average 0.6% per month. Annual growth of the consumer price index along three models will come on average at 3.9%. The same indicator of the producer price index is forecast at 7.5%. The producer price indexes computed by Rosstat are forecast to grow at average monthly rates in July-December 2018: for mining and quarrying 1.3%, manufacturing 0.9%, utilities (electricity, gas, and steam) 1.0%, food products 0.7%, textile and sewing industry 0.4%, wood products 0.7%, pulp and paper industry 0.6%, coke and refined petroleum 1.3%, for chemical industry 1.1%, for basic metals and fabricated metal 0.1%, for machinery and equipment 0.4%, and for motor vehicles manufacture 0.5%.

Annual growth of the producer price indexes along types of economic activity will constitute on average 9.8%. At 2016-end, the maximum annual growth is forecast in production of coke and petroleum products will hit 19.1%, minimum – production of electricity, gas, and water (3.3%).

#### **The Cost of the Monthly per Capita Minimum Food Basket**

*This section presents calculations of forecast values of the cost of the monthly per capita minimum food basket over July and December of 2018. The forecasts were made on the basis of time series with use the Rosstat data over the period from January 2000 to June 2018. The results are shown in Table 5.*

As can be seen from Table 5, the minimum set of food products' cost is forecast to grow compared to the corresponding period of the previous year. At the same time, the minimum set of

food products is forecast to average RUB 3,884.2. The minimum set of food products cost is forecast to grow on average around 2.2%. Annual growth of the minimum set of food products will average around 4.6% in 2018.

**Indexes of Freight Rates**

This section presents calculations of forecast values of freight rate indexes on cargo carriage<sup>1</sup>, made on the basis of time-series models evaluated on the Rosstat data over the period from September 1998 to April 2018. Table 6 shows the results of model calculations of forecast values in July-December of 2018. It should be noted that some of the indexes under review (for instance, the pipeline rate index) are adjustable ones and for that reason their behavior is hard to describe by means of the time-series models. As a result, the future values may differ greatly from the real ones in case of the centralized increase of rates in the period of forecasting or in case of absence of such an increase in the forecasting period, but with it taking place shortly before the beginning of that period.

According to the forecast results for July-December 2018, the composite index of transport tariffs will be growing with average monthly rate 0.03%. At the same time, in October 2018, the seasonal decrease of the index is expected by 4.1%age points, and in July 2018 – growth by 3.5%age points.

The index of motor freight tariffs will decrease in the course of given six months at an average monthly rate of -0.3%.

The index of pipeline tariffs will be growing at an average monthly rate of 0.6% in the course of the next six months.

At 2018-end, the composite index of transport tariffs will grow by 1.7%, the index of pipeline tariffs – by 4.7%, and the index of motor freight tariffs will decrease by 1.7%.

**World Prices of Natural Resources**

This section presents calculations of such average monthly values of Brent crude prices (US\$ per

barrel), the aluminum prices (US\$ per ton), the gold prices (\$ per ounce), the copper prices (US\$ per ton), and the nickel prices (US\$ per ton) over July-December of 2018 as were received on the basis of non-linear models of time series evaluated on the basis of the IMF data over the period from January 1980 to May 2018.

The crude oil price is forecast to average around \$91.3 per barrel, which is above its corresponding year-earlier indexes on average by 54.9%. The Aluminum prices are forecast to average around \$2,435.0 per ton and their average forecast decrease constitutes around 16.0% compared to the same level of last year. The gold price is forecast to average \$1,310.0 per ounce. The copper price is forecast to average \$6,874 per ton, and prices for nickel –around \$16,752 per ton. The average forecast price increase for gold constitutes around 3.0%, the average increase of copper prices – around 2.0%, and average increase of nickel prices – 47.0% compared to the corresponding level of last year.

At 2018-end, the forecast increment of prices on oil, aluminum, gold, and nickel compared with late 2017 will constitute 50.5%, 8.7%, 4.9%, and 35.5%, respectively. The forecast decrease of copper prices will come to 5.3%.

## MONETARY INDEXES

The future values of the monetary base (in the narrow definition: cash funds and the Fund of Mandatory Reserves (FMR) and  $M_2$  monetary aggregate over the period from July to December of 2018 were received on the basis of models of time-series of respective indexes calculated by the CBR<sup>1</sup> over the period from October 1998 to June (May – for  $M_2$  time series) 2018. Table 8 presents the results of calculations of forecast values and actual values of those indexes in the same period of previous year. It is to be noted that due to the fact that the monetary base is an instrument of the CBR policy, forecasts of the monetary base on the basis of time-series models are to a certain extent notional as the future value of that index is determined to a great extent by decisions of the CBR, rather than the inherent specifics of the series.

<sup>1</sup> The data on the specific month is given in accordance with the methods of the CBR as of the beginning of the following month.

## INTERNATIONAL RESERVES

In July-December 2018, the monetary base will be growing at an average monthly rate of 0.7%. In the forecast period the monetary index  $M_2$  will be growing at the average rate of 0.2%.

The annual increment of the monetary base in 2018 will come along forecasts 12.6%, and index  $M_2$  – 7.7%.

## INTERNATIONAL RESERVES

*This section presents the outputs of the statistical estimation of such future values of the international reserves of the Russian Federation<sup>1</sup> as were received on the basis of evaluation of the model of time series of the gold and foreign exchange reserves on the basis of the data released by the CBR over the period from October 1998 to May 2018. That index is forecast without taking into account a decrease in the amount of reserves due to foreign debt payment and for that reason the values of the volumes of the international reserves in the months where foreign debt payments are made may happen to be overestimated (or otherwise underestimated) as compared to the actual ones.*

Subsequent to the forecast results for July-December 2018, the international reserves will be growing at an average monthly rate of 0.5%. The forecast increment of the international reserves in 2018 will come to 9.5% in annual terms.

## FOREIGN EXCHANGE RATES

*The model calculations of prospective values of the foreign exchange rates (RUB per USD and USD per euro) were made on the basis of assessment of the time series models (ARIMA) and structural models (SM) of the relevant indicators released by the Central Bank of Russia as of the last date of each month over the periods from October 1998 to June 2018 and from February 1999 to June 2018,<sup>2</sup> respectively.*

In July-December 2018, USD/RUB average exchange rate is forecast along two models in the amount of RUB 62.45 for USD along two models. The forecast value of the index will average RUB 62.42 for USD along two models.

Over the period under review, Euro/USD exchange rate is forecast during the forecast period at USD 1.19 per 1 euro. The forecast value of the index will average USD1.20 per 1 euro along two models.

### THE LIVING STANDARD INDEXES

*This section (Table 12) presents calculations of forecast values of indexes of real wages, real disposable income and real income<sup>1</sup> as were received on the basis of the model of time series of respective indexes computed by Rosstat and taken over the period from January 1999 to May 2018. The above indexes depend to a certain extent on the centralized decisions on raising of wages and salaries to public sector workers, as well as those on raising of pensions, scholarships and allowances; such a situation introduces some changes in the dynamics of the indexes under review. As a result, the future values of the indexes of real wages and real disposable income calculated on the basis of the series which last observations are either considerably higher or lower than the previous ones due to such a raising may differ greatly from those which are implemented in reality.*

According to the results presented in Table 11, the average monthly growth of the real disposable cash income is forecast at the rate of 3.1% compared to the previous year; the real cash income – 3.3%, the real accrued wages – 9.1%.

At 2018-end, the forecast increment of the real disposable cash income will come to 2.5%, the real cash income – by 2.9%, and increment of the real wages – by 9%.

### EMPLOYMENT AND UNEMPLOYMENT

*For the purpose of calculation of the future values of the employment (of the number the gainfully employed population) and the unemployment (the total number of the unemployed), models of the time series evaluated over the period from October 1998 to April 2018 on the basis of the monthly data released by Rosstat<sup>2</sup> were used. The unemployment was calculated on the basis of the models with results of the findings from business surveys<sup>3</sup> too. It is to be noted that feasible logical inconsistencies<sup>4</sup>*

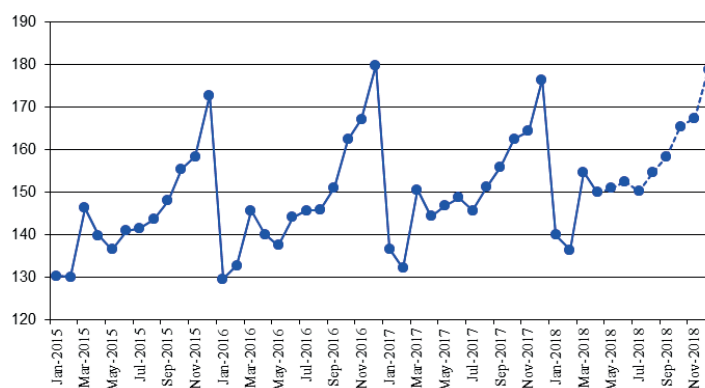
According to ARIMA-model forecast (Table 12), in July-December 2018, the increase of the number of employed in the economy will average 1.2% per month against the corresponding period of the previous year. The forecast index of the number of employed in the economy constitutes 72.2 million persons at 2018-end.

The decrease of the total number of jobless is forecast to average 6.6% per month against the same period of last year. The average number of jobless at 2018-end is forecast at 3.65 million persons.

Fig. 1b. The NRU HSE industrial production index (ARIMA-model) (% of January 2010)

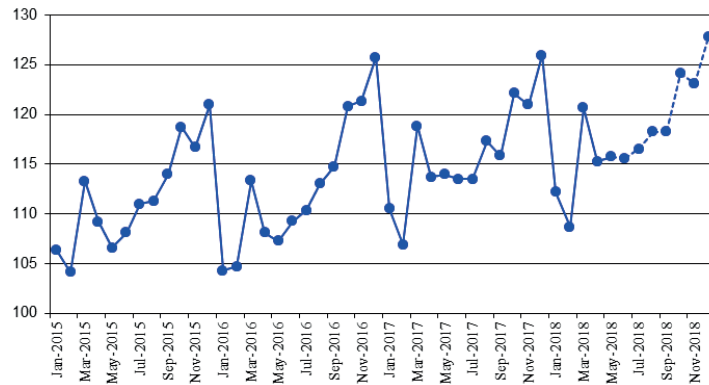


Fig. 2a. The Rosstat industrial production index for mining (% of December 2001)

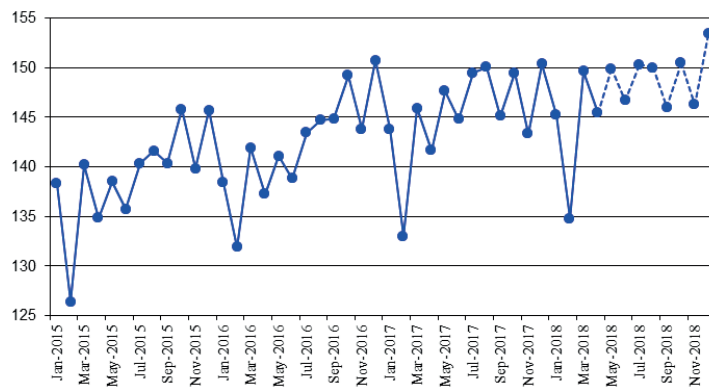


Fig. 2b. The NRU HSE industrial production index for mining (% of January 2010)

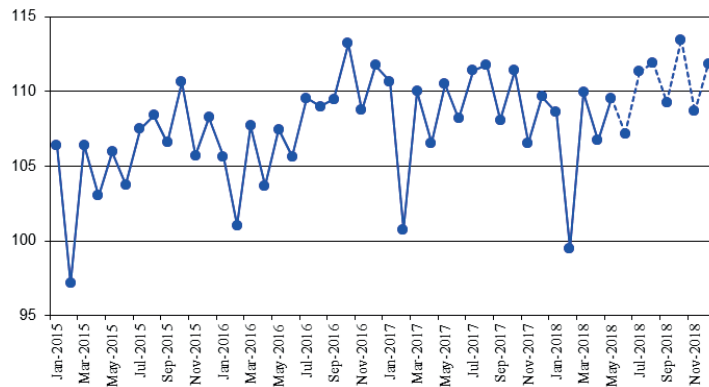


Fig. 3a. The Rosstat industrial production index for manufacturing (% of December 2001)

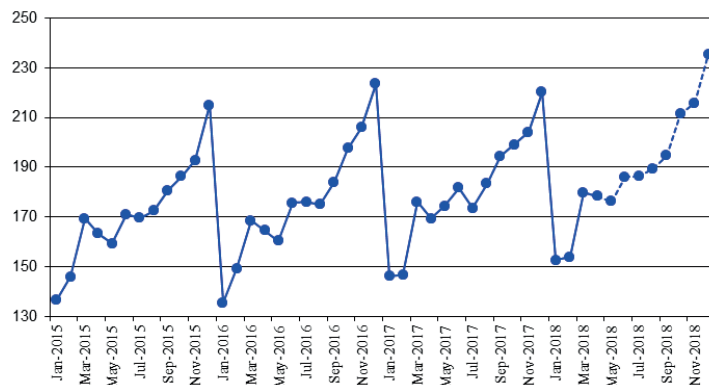


Fig. 3b. The NRU HSE industrial production index for manufacturing (% of January 2010)

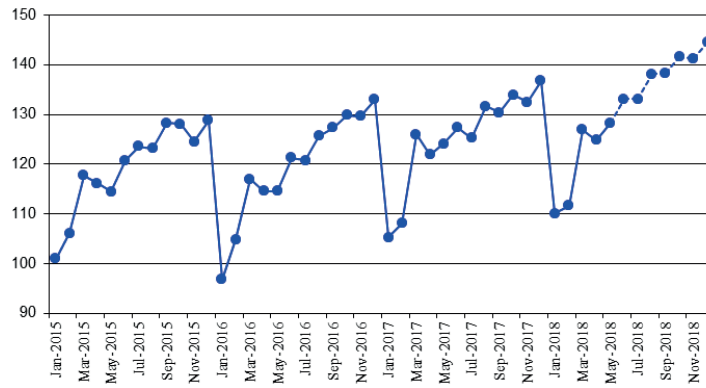


Fig. 4a. The Rosstat industrial production index for utilities (electricity, water, and gas) (as a percentage of that in December 2001)

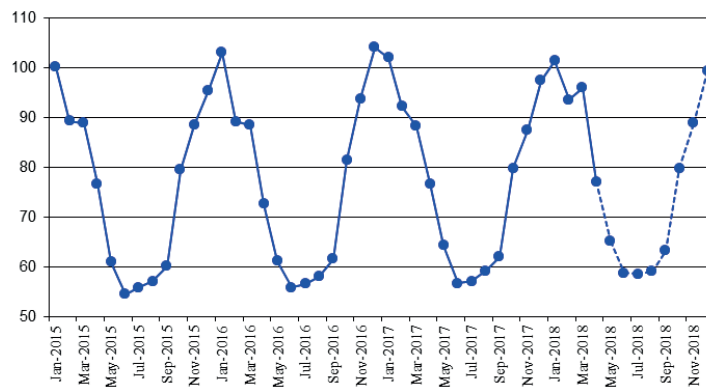


Fig. 4b. The NRU HSE industrial production index for utilities (electricity, water, and gas) (as a percentage of that in January 2010)

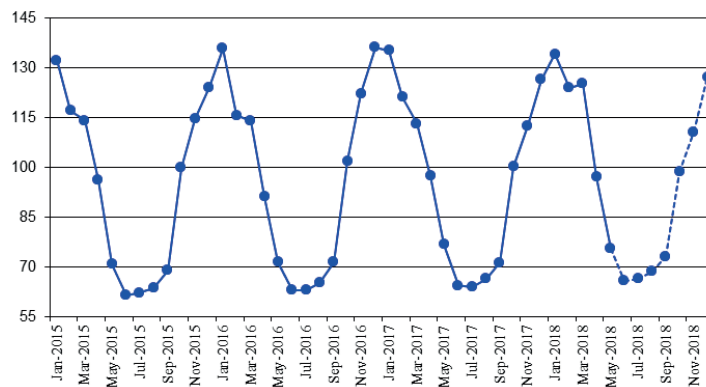
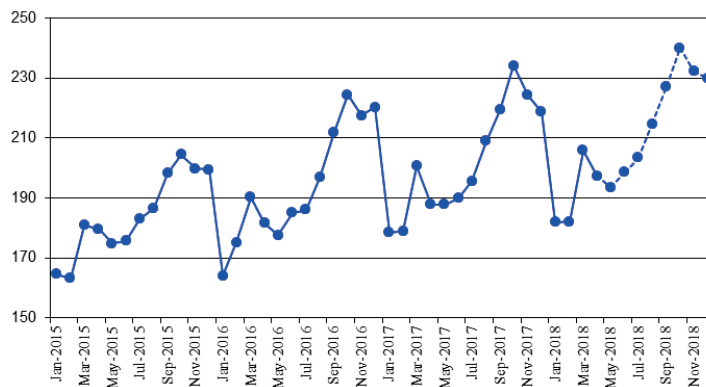


Fig. 5a. The Rosstat industrial production index for food products (as a percentage of that in December 2001)

Fig. 5b. The NRU HSE industrial production index for food products (as a percentage of that in January 2010)

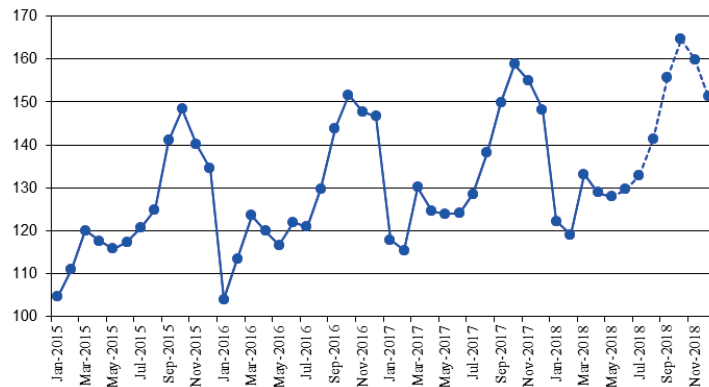


Fig. 6a. The Rosstat industrial production index for coke and petroleum (as a percentage of that in December 2001)

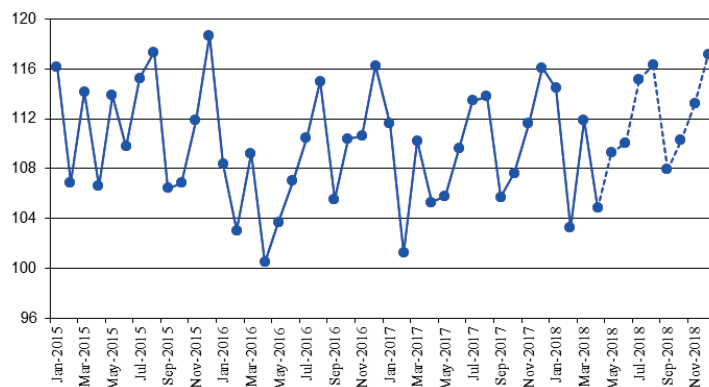


Fig. 6b. The NRU HSE industrial production index for petroleum and coke (as a percentage of that in January 2010)

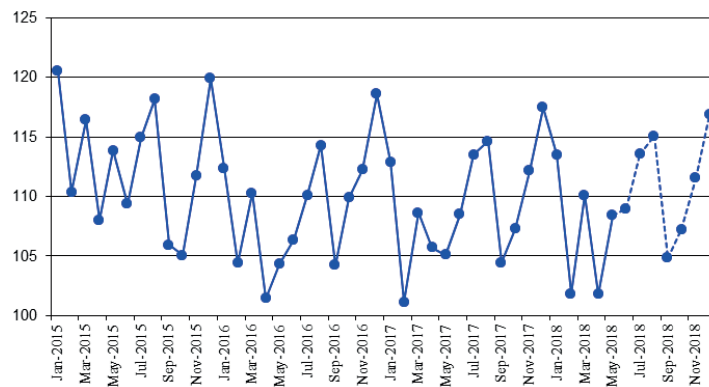


Fig.7a. The Rosstat industrial production index for primary metals and fabricated metal products (as a percentage of that in December 2001)

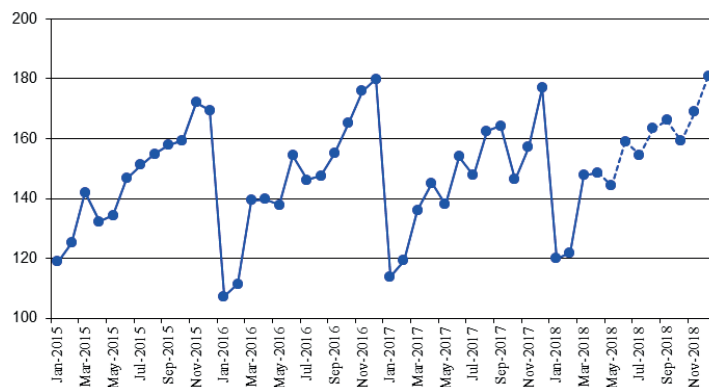




Fig. 7b. The NRU HSE industrial production index for primary metals and fabricated metal products (as a percentage of that in January 2010)

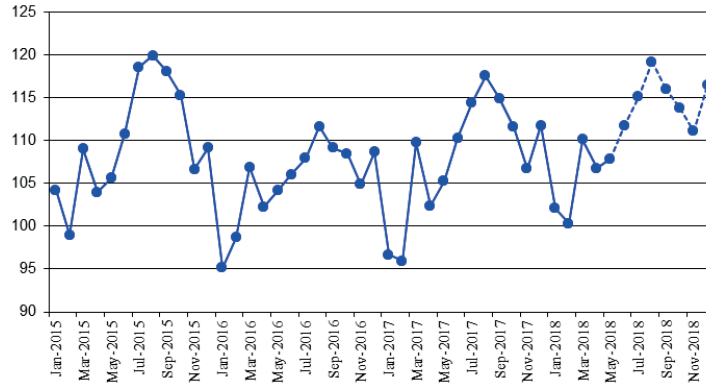


Fig. 8a. The Rosstat industrial production index for machinery (as a percentage of that in December 2001)

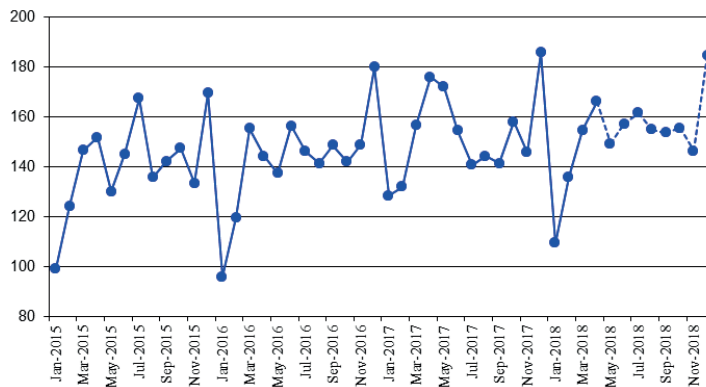


Fig. 8b. The NRU HSE industrial production index for machinery (as a percentage of that in January 2010)

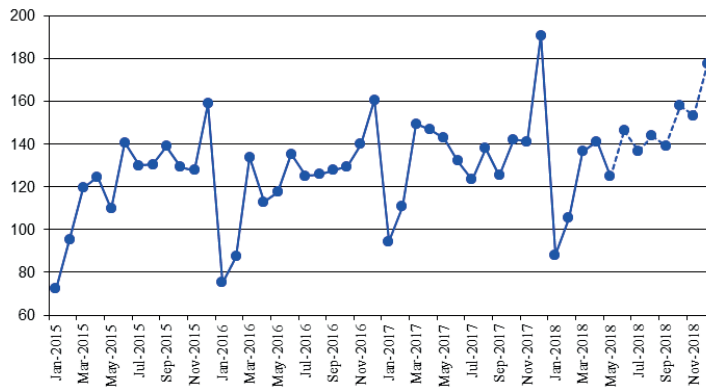
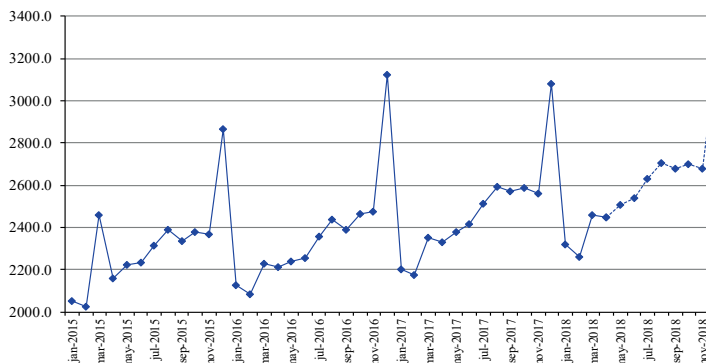


Fig. 9. The volume of retail sales (billion RUB)

Fig. 9a. The real volume of retail sales (as a percentage of that in the same period of the previous year)

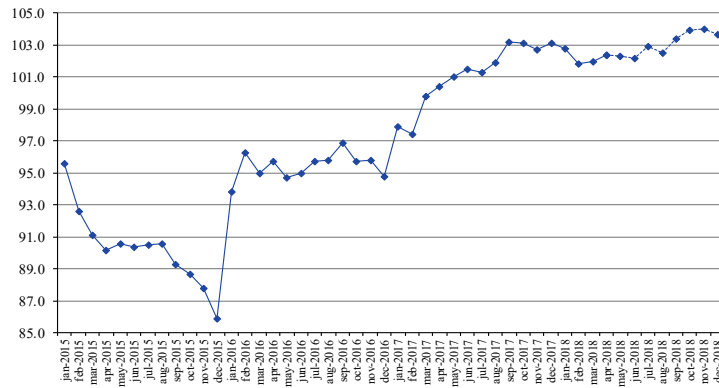


Fig. 10. Export to all countries (billion USD)

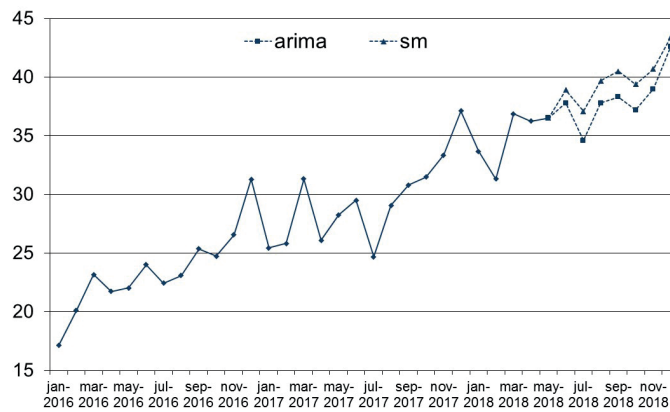


Fig. 11. Export to countries outside the CIS (billion USD)

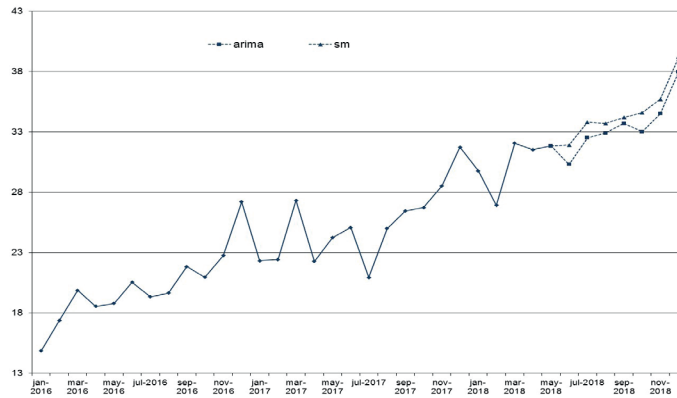


Fig. 12. Import from all countries (billion USD)

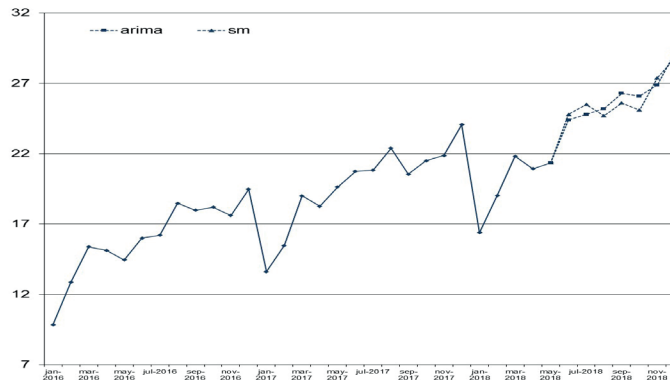


Fig. 13. Import from countries outside the CIS (billion USD)

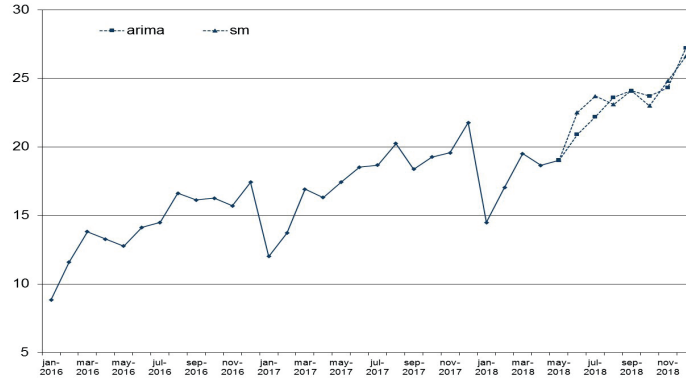


Fig. 14. The consumer price index (as a percentage of that in December of the previous year)

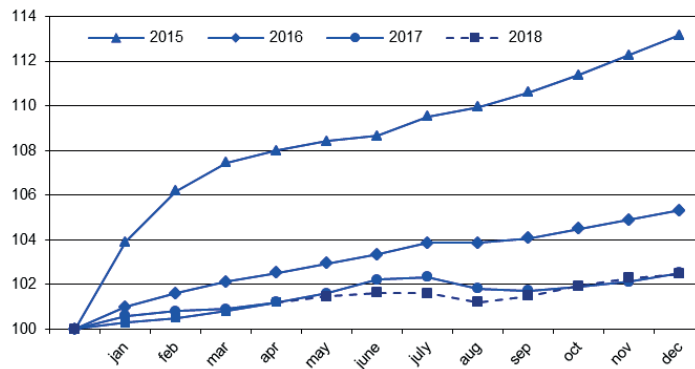


Fig. 14a. The consumer price index (as a percentage of that in December of the previous year) (SM)

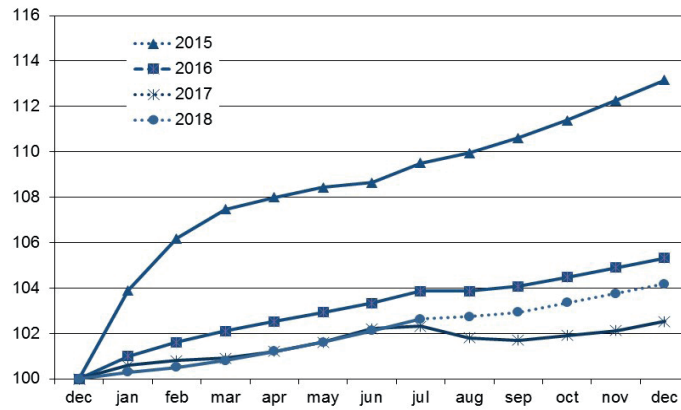
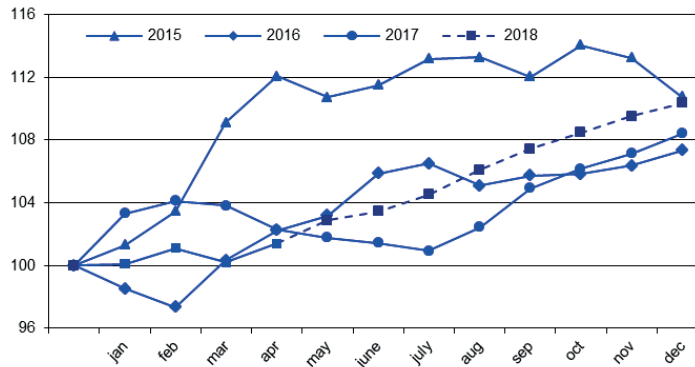


Fig. 15. The producer price index for industrial goods (as a percentage of that in December of the previous year)

(as a percentage of that in December of the previous year)

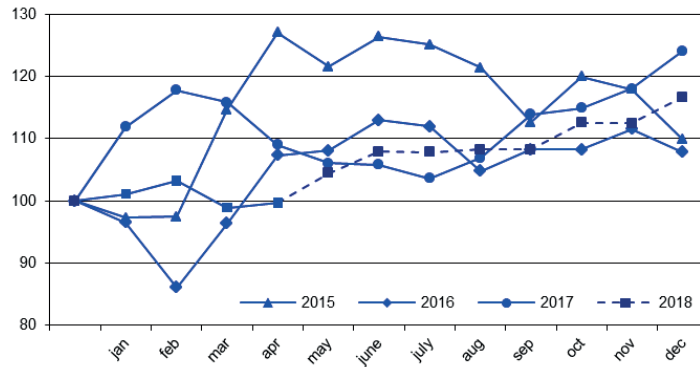


Fig. 17. The price index for manufacturing  
(as a percentage of that in December of the previous year)

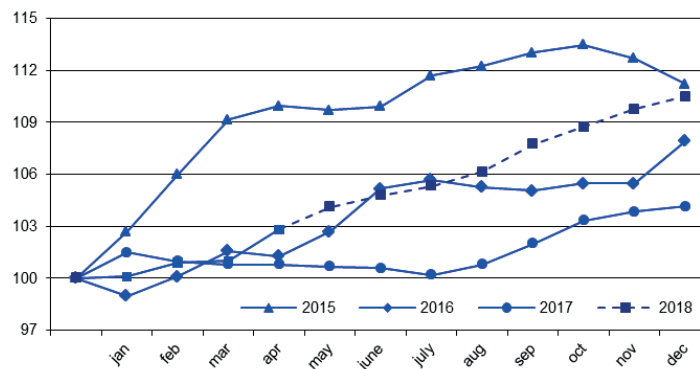


Fig. 18. The price index for utilities (electricity, water, and gas)  
(as a percentage of that in December of the previous year)

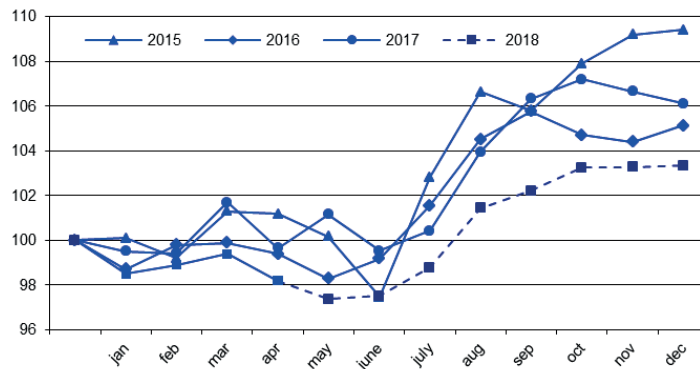


Fig. 19. The price index for food products  
(as a percentage of that in December of the previous year)

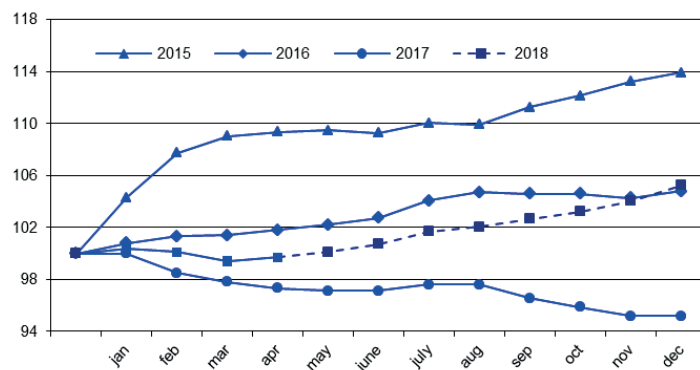


Fig. 20. The price index for the textile and sewing industry (as a percentage of that in December of the previous year)

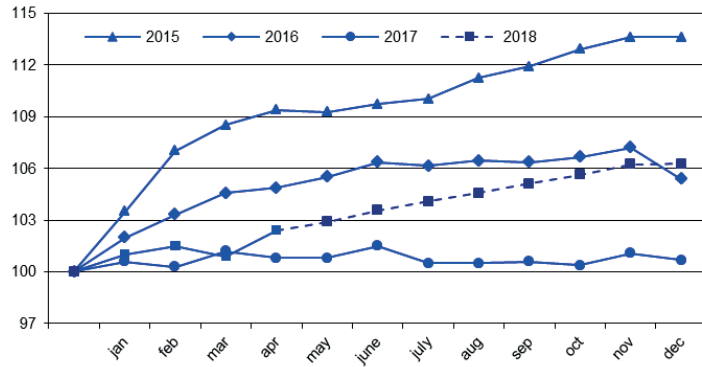


Fig. 21. The price index for wood products (as a percentage of that in December of the previous year)

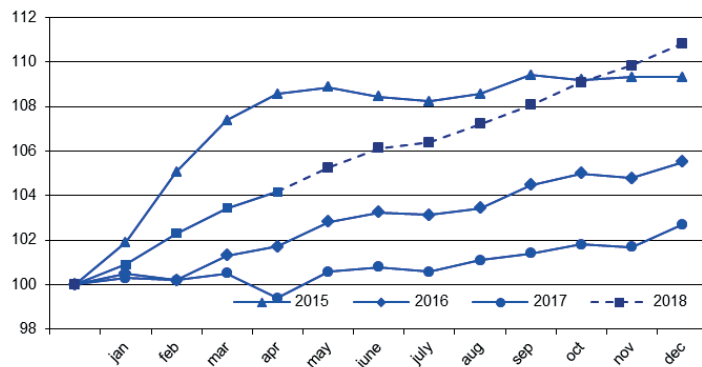


Fig. 22. The price index for the pulp and paper industry (as a percentage of that in December of the previous year)

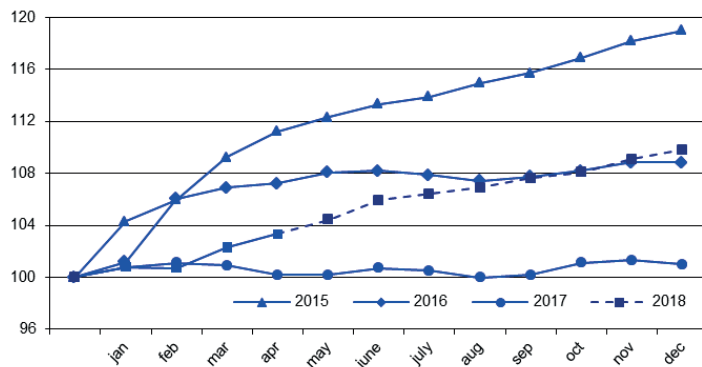
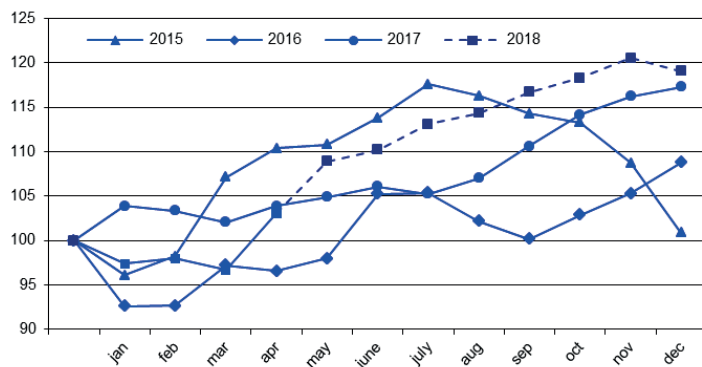


Fig. 23. The price index for coke and petroleum (as a percentage of that in December of the previous year)

Fig. 24. The price index for the chemical industry (as a percentage of that in December of the previous year)

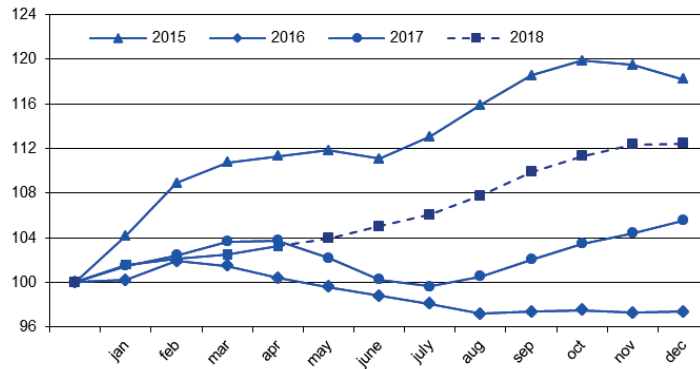


Fig. 25. The price index for primary metals and fabricated metal products (as a percentage of that in December of the previous year)

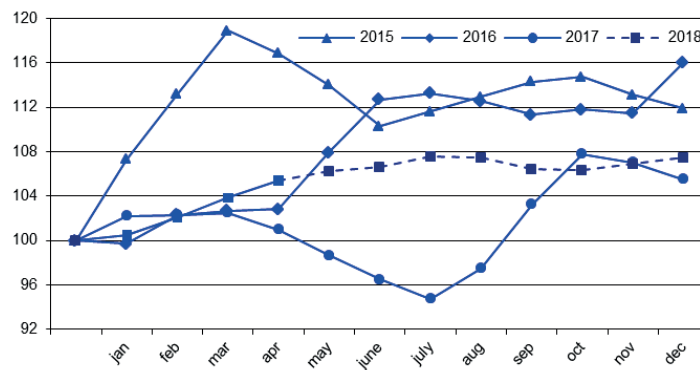


Fig. 26. The price index for machinery (as a percentage of that in December of the previous year)

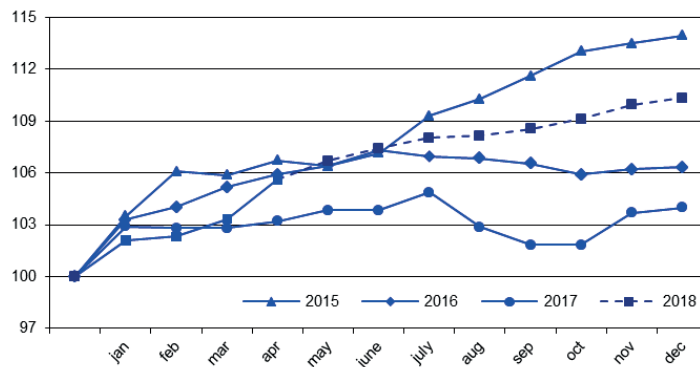


Fig. 27. The price index for transport equipment manufacturing (as a percentage of that in December of the previous year)

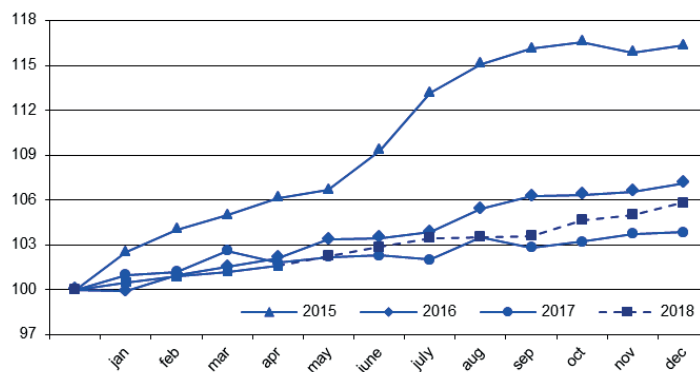


Fig. 28. The cost of the monthly per capita minimum food basket (RUB)

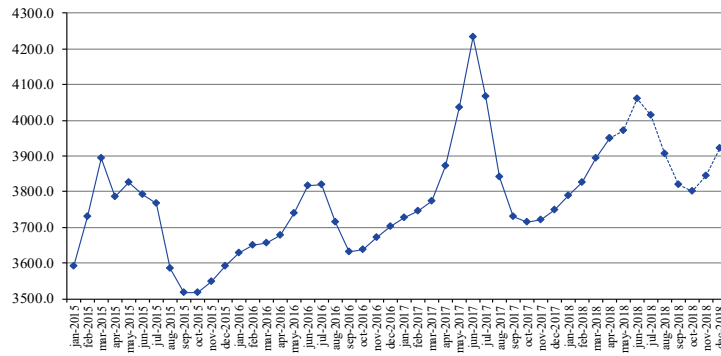


Fig. 29. The composite index of transport tariffs (for each year, as a percentage of that in the previous month)

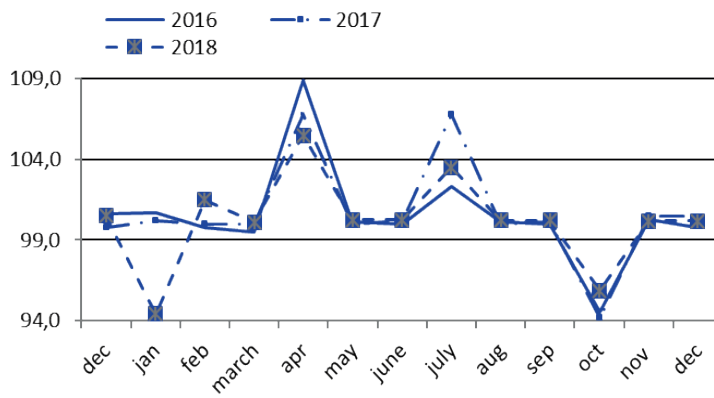


Fig. 30. The index of motor freight tariffs (for each year, as a percentage of that in the previous month)

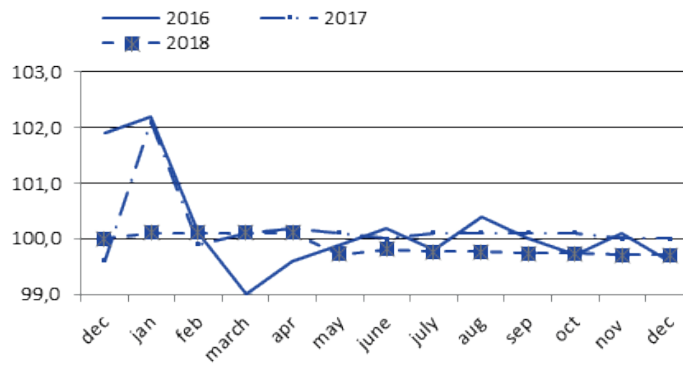
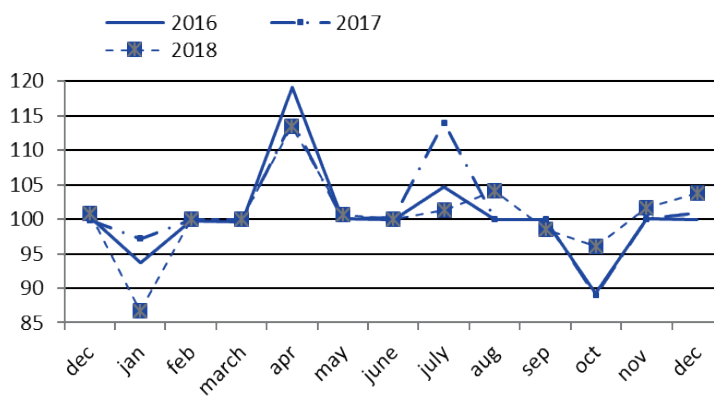


Fig. 31. The index of pipeline tariffs (for each year, as a percentage of that in the previous month)

Fig. 32. The Brent oil price (\$ per barrel)

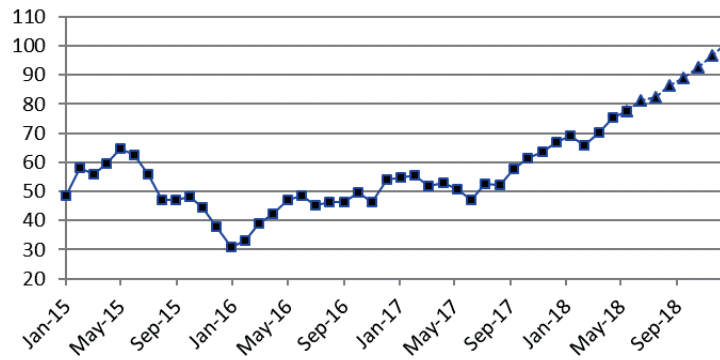


Fig. 33. The aluminum price (\$ per ton)

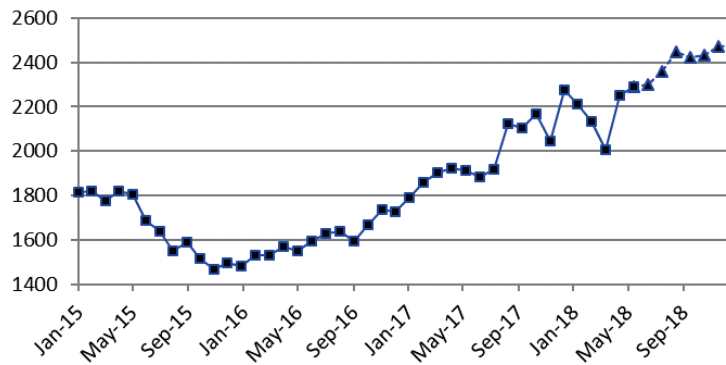


Fig. 34. The gold price (\$ per ounce)

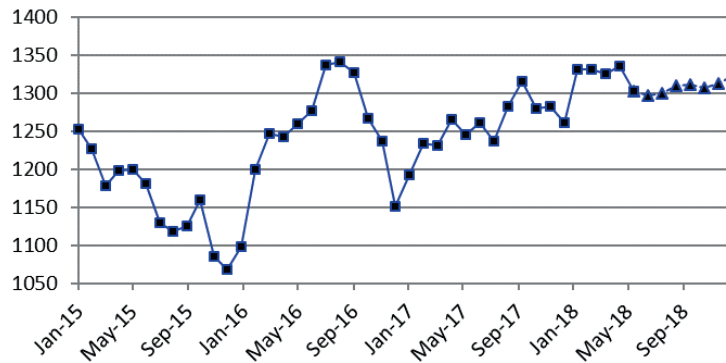


Fig. 35. The nickel price (\$ per ton)

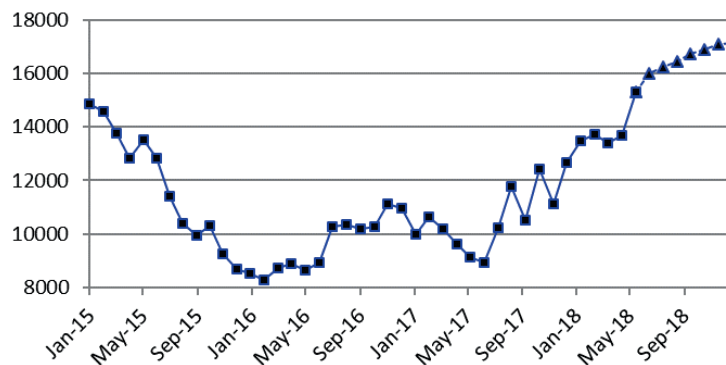




Fig. 36. The copper price (\$ per ton)

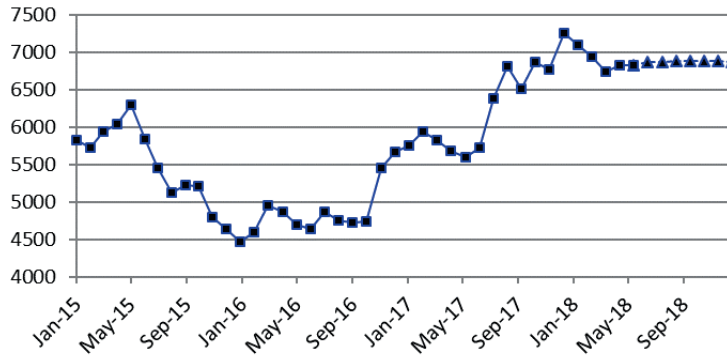


Fig. 37. The monetary base, billion RUB

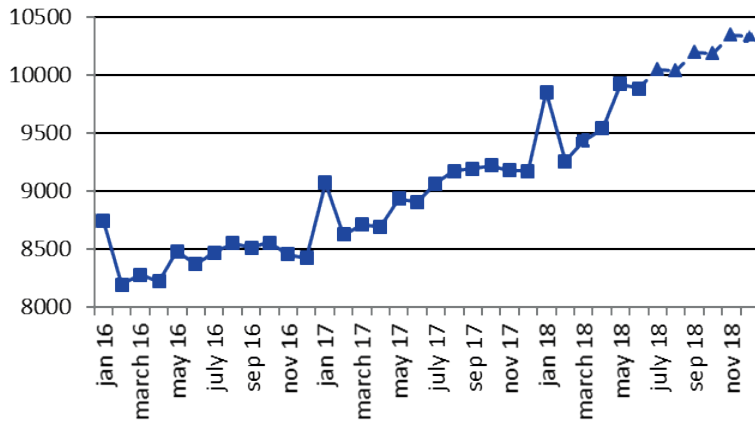


Fig. 38. M2, billion RUB

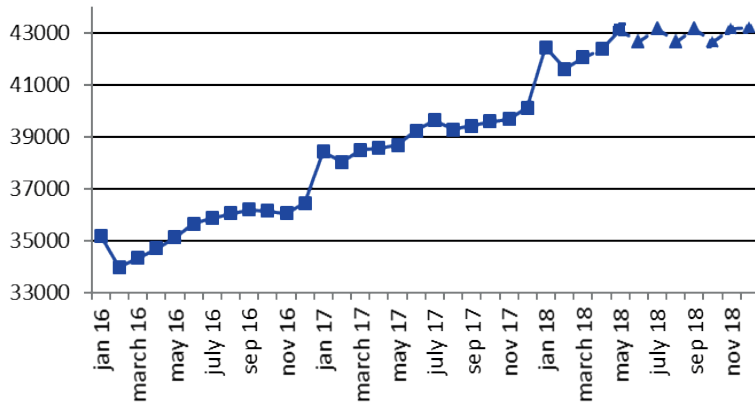
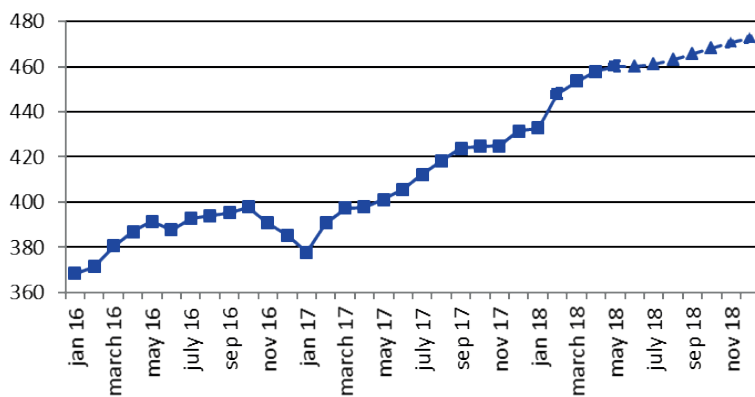


Fig. 39. The international reserves of the Russian Federation, million USD

Fig. 40. The RUB/USD exchange rate

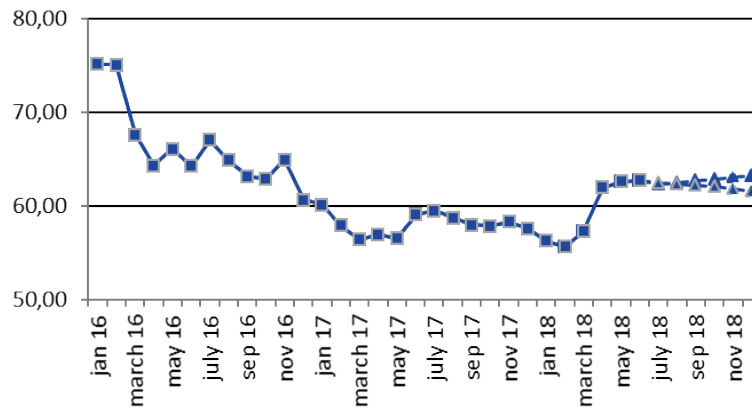


Fig. 41. The USD/EUR exchange rate

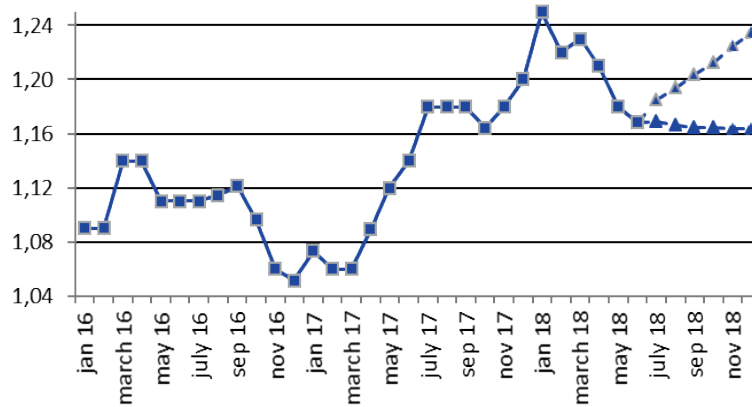


Fig. 42. Real disposable cash income  
(as a percentage of that in the same period of the previous year)

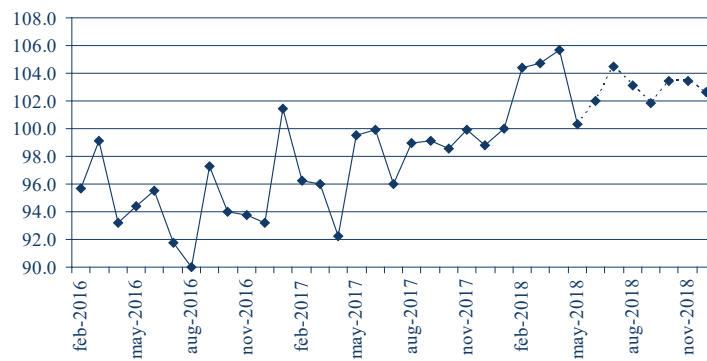


Fig. 43. Real cash income  
(as a percentage of that in the same period of the previous year)

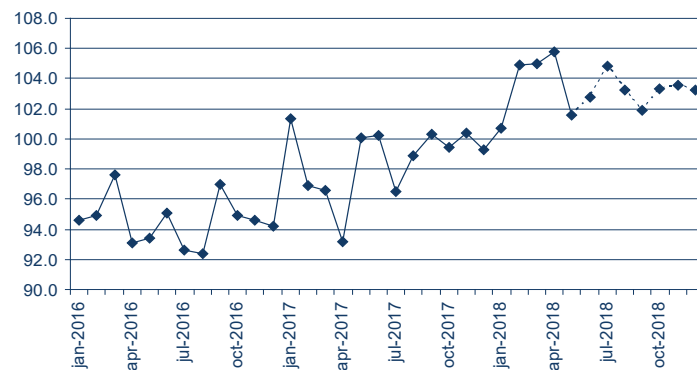


Fig. 44. Real accrued wages  
(as a percentage of those in the same period of the previous year)

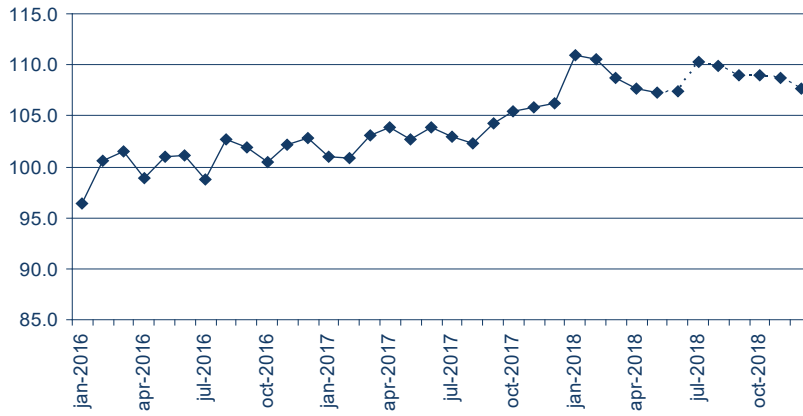


Fig. 45. Employment (million people)

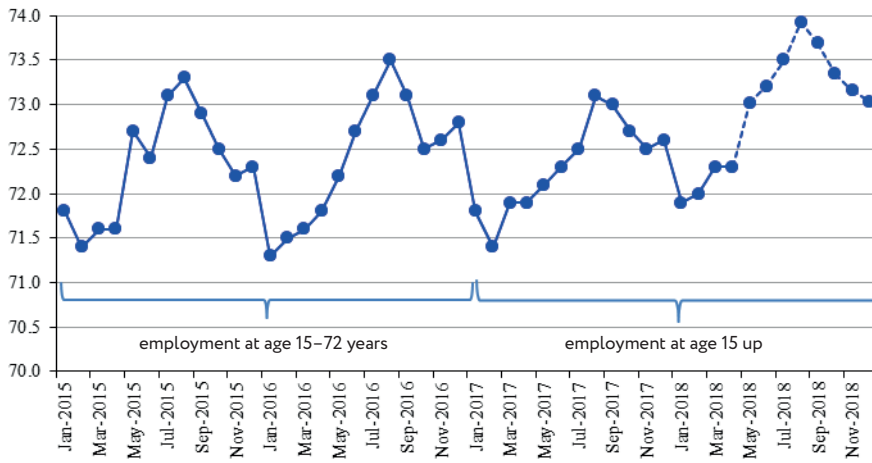


Fig. 46. Unemployment (million people)
